Sir,

In producing herewith arrested accused persons namely (1) Badruddin Ansary (41), S/O Lt. Irshad Ansary of Bhelatard, (2) Suleman Ansary (40), S/O Lt. Sahadul Ansary of Kukurtanga, (3) Anuj Kumar (28), S/O Bhagbat Kumar of STPS Township, Qtr No. F-74/3A, All are PS - Santaldih, Dist. -Purulia, (4) Fatik Gorain (26), S/O Dulal Ch. Gorain of Ghatikuli near Gour Mandir Asansol, PS - Asansol (south), Dist.- Paschim Bardwan, (5) Samit Singha (23), S/O Sanjay Singha, (6) Amit Kumar Singha (25), S/O Ajay Lal Singha, Sl. No. 5 & 6 are Vill. - Manipur, PS - Para, Dist. - Purulia, (7) Pintu Ray (22), S/O Gurupada Ray of Chasnalla, and (8) Bikash Kumar @ Bouri, (22), S/O Mohan Bouri of Sudamdih, Sl. I, SI Sourav Kanti Das of Santaldih PS do hereby lodge complaint that today (21.11.2020) at 13:15 hrs, when myself along with force were engaged in mobile duty at Santaldih PS area and found the above noted persons were moving at Shaympur more under Santaldih PS, without wearing Mask or any face guard, as such I, detained them on that spot. On being asked the above noted persons could not able to give any satisfactory answer for not wearing Mask / face guard in this pandemic situation. As such the above noted persons violated the order during the pandemic situation duly promulgated by Govt. of West Bengal in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, the above noted persons were arrested after maintaining all the formalities regarding arrest and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188 IPC & Read with section 51(1)(b) of National Disaster Management Act, 2005 may kindly be initiated against (1) Badruddin Ansary (41), S/O Lt. Irshad Ansary of Bhelatard, (2) Suleman Ansary (40), S/O Lt. Sahadul Ansary of Kukurtanga, (3) Anuj Kumar (28), S/O Bhagbat Kumar of STPS Township, Qtr No. F-74/3A, **All are** PS – Santaldih, Dist. – Purulia, (4) Fatik Gorain (26), S/O Dulal Ch. Gorain of Ghatikuli near Gour Mandir Asansol, PS – Asansol (south), Dist.- Paschim Bardwan, (5) Samit Singha (23), S/O Sanjay Singha, (6) Amit Kumar Singha (25), S/O Ajay Lal Singha, **Sl.
