Sir,

With due respect and humble submission, I beg to submit that today i.e, on 20.11.2020 at 10:00 hrs. while I ASI Gurucharan Sahis along with C/1485 Swarup Nandi and C/557 Ambuj Kr. Mondal both of Santuri PS were performing morning mobile duty at Poradiha area received a credible source information that one Biswajit Tantubai @ Bishu Tanti, S/O- Late Durgadas Tantubai of village Mokra, P.S Santuri, Dist. Purulia along with others accumulated huge quantity of coal by illegal means in a hidden place on bushy area at Jadurdih village under Rakta Mouza with intension to run clandestine business. And now Biswajit Tantubai @ Bishu Tanti and some others are loading said coal in tractors for smuggle the coal. After informing O/C Santuri PS and after getting kind permission I along with force left Jadurdi village area to work out the aforesaid information. On reaching at place at 10:45 hrs found huge quantity (approx 50 MT) of coal is accumulated and the said person namely Biswajit Tantubai @ Bishu Tanti S/O Late Durgadas Tantubai of village Mokra, P.S Santuri, Dist. Purulia and 03 others unknown persons are on that spot and loading coal in a tractor. Seeing the police party they left the tractor and fled away though I have tried to interrogate them but could not as they fled away ignoring my call. I also wanted to interrogate the local people but they all fled away as Biswajit Tantubai @ Bishu Tanti and others are dangerous and desperate in nature. During enquiry, it is transpired that these persons under the leadership of Biswajit Tantubai @ Bishu Tanti have been procuring, accumulating and smuggling the said coal by means of theft or any fraudulent manner to run a clandestine business for wrongful gains by illegal business and habitual to run this business. Accordingly I have seized from the spot (1) One tractor without Registration Number (Model No-380, Engine No- J23596, Chassis No- 926513159010) with approx 05 MT Coal loaded Trolley under proper seizure list. I have also sealed & labeled approx 01 (one) K.G coal as sample from the major contraband. I also seized (2) Approx 50 MT coal which was dumped beside the tractor, (3) 12 (twelve) pieces of iron made Belcha (4) 15 (Fifteen) pieces of Basket, (5) 03 (Three) piece of axe, (6) 04 (Four) pieces of spade under proper seizure list duly signed by the available witnesses. Thereafter arranging a public driver I brought the aforesaid seized articles at Santuri P.S compound.

I therefore pray before you to lodge a specific case against Biswajit Tantubai @ Bishu Tanti S/O Late Durgadas Tantubai of village Mokra, P.s Santuri, Dist. Purulia owner and driver of tractor (Model No-380, Engine No- J23596, Chassis No- 926513159010) and others under proper section of law.
