In producing herewith one seized vehicle i.e Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) loaded with sand. The fact of the case in brief is that on 03/11/2020 I,S.I Biswarup Roy of Santuri P.S along with force were on evening mobile duty. During mobile duty on 03/11/2020 at about 18:45 hrs received credible source information that the above noted (Tractor) is coming from Damodar river side loaded with sand. After receiving this information we were proceeding towards Damodar river ghat through infront of Vikash Metal Factory road under Santuri P.S. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No-RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
