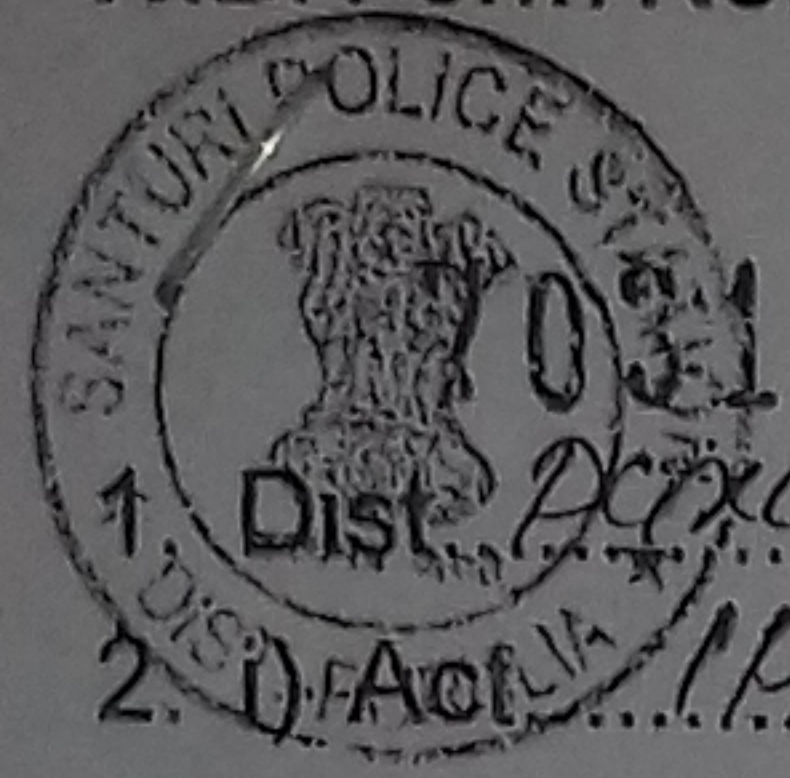

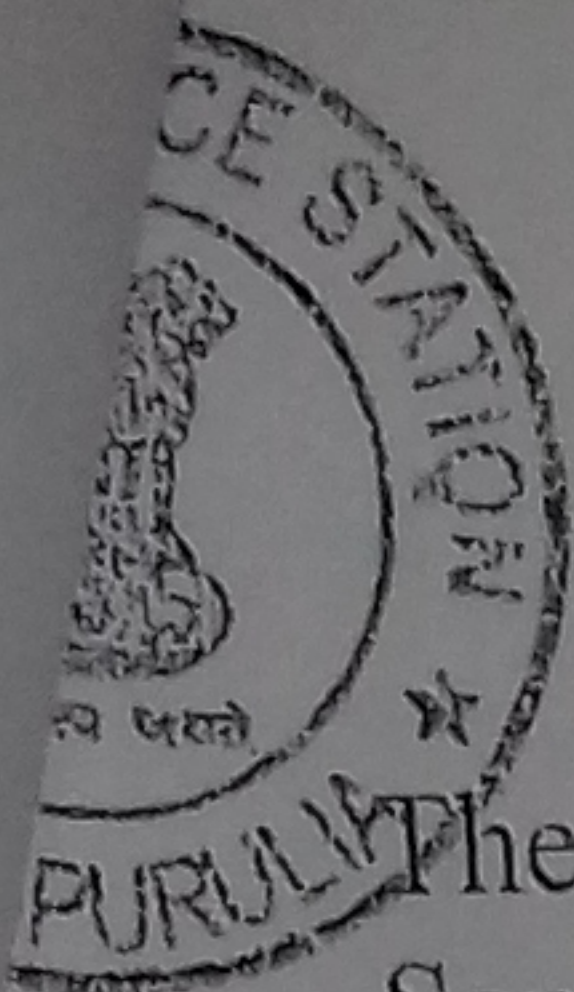

Sir,

In producing herewith one seized vehicle i.e Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) loaded with sand. The fact of the case in brief is that on 03/11/2020 I, S.I Biswarup Roy of Santuri P.S along with force were on evening mobile duty. During mobile duty on 03/11/2020 at about 18:45 hrs received credible source information that the above noted (Tractor) is coming from Damodar river side loaded with sand. After receiving this information we were proceeding towards Damodar river ghat through in front of Vikash Metal Factory road under Santuri P.S. When we reached near "Vikash Metal Factory" main gate, found that the above noted (Tractor) was coming from Damodar river side loaded with sand. On seeing the Police party the driver of the said tractor stopped the tractor in a distance at "Vikash Metal Factory" main gate and tried to unload the loaded sand from the said tractor. We rushed to the tractor but the driver then fled away after keeping the tractor on that place at 19:05 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of loaded sand in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Santuri P.S. As such there is every reason to believe that the driver and owner of the Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra B 275DI, Bhoomiputra bearing Reg. Number-WB 81/1446, & having Engine No- RHG2EAN7174 and Chassis No. MBNABAEAKHRG01406, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
