Sub: Report of an accident on Purulia- Ranchi Road (NH-32) in front of Sanik School Vill- Ramnagar under Tamna PS, Dist- Purulia


Sir,

I ASI Sk Guljar of Purulia (M) PS along with C/50 Dharanidhar Mahanty NVF/969 Pralay Mahato , HG/1576 Shaktipada Mahato was performing Night mobile duty vide Purulia (M) PS CC no 3115/2020 Dated 25/11/2020 in consonance with Purulia (M) PS GDE no 966 Dated 25/11/2020 by the detailed vehicle having no WB56M 8233 along the Purulia- Ranchi Road (NH-32). While I was moving from Imundih more towards Purulia (T) along Purulia- Ranchi Road (NH-32) , at that time one Cyclist abruptly appeared afore our vehicle at about 19:30 hrs in front of Sanik School Vill- Ramnagar under Tamna PS ,Dist- Purulia. The driver of our vehicle tried to withhold the brake of the vehicle which he could not help but collide the cyclist. Forthwith, I along with force shifted the cyclist by our vehicle in the emergency of Deben Mahato Sadar Hospital. After that, I tried to identify the person so that I can inform his family member. Subsequently, I informed my superior about the accident. Later on the attending Doctor declared to me that the person succumbed to his injuries. After the sustainable search the person identified as Dasarath Majhi S/O Late Harendranath Majhi of Vill- Manguria, PS- Tamna, Dist- Purulia and informed his family member.

In the supra circumstances, the rash and negligent driving of the driver of the vehicle having no WB56M 8233 cannot be disapproved.

Ergo, I pray before you that a necessary legal action may kindly be taken against the driver of the vehicle having no WB56M 8233 over the accident and a FIR may kindly be lodged for the investigation of the accident.
