Sir,

In producing here with one arrested accused namely Rakesh Verma (45 Yrs) S/O Surendra Verma of Vill- Kamalashan near Kamala Mandir, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 12 bottles (in sealed condition) DIL. KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle

SI Subrata Sadhu of Adra PS do here by lodged a complaint against accused namely Rakesh Verma (45 Yrs) S/O Surendra Verma of Vill- Kamalashan near Kamala Mandir, PS-Adra, Dist- Purulia to the effect that on 22/12/20 at about 03:35 hrs I received a telephonic information from a reliable source during my night mobile duty at P.S area vide Adra PS CC NO-4035/20 dtd 21/12/20 and GIDE no-B07/20 that one Rakesh Verma (45 Yrs) S/O Surendra Verma of Vill- Kamalashan near Kamala Mandir, PS-Adra, Dist- Purulia has been stock of country spirit illegally at his House/ Shop at Kamalashan Village. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Kamalashan at about 04:05 hrs and hold raid in the house/ Shop of said Rakesh Verma (45 Yrs) S/O Surendra Verma and found that the said person selling liquor at his house/shop and after seeing the Police party some person fled away and said Rakesh Verma has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Rakesh Verma (45 Yrs) S/O Surendra Verma of Vill- Kamalashan near Kamala Mandir, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Rakesh Verma (45 Yrs) S/O Surendra Verma of Vill- Kamalashan near Kamala Mandir, PS-Adra, Dist- Purulia under proper section of law.
