Sir,

In producing herewith one Sikandar Momin, S/O-Azim Momin of Vill-Sirkadih, PS-Baghmundi, Dist-Purulia to the effect that on 06.12.2020 while I SI Snehasish Mondal along with force 1) C/458 Krishna Chandra Adhikary and 2) C/530 Traun Kumar Pal Chowdhury both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing mobile duty vide Baghmundi PS GDE No- 255, Dated- 06/12/2020. During my mobile duty when myself along with force reached at Charida More at 16:25 hrs and found above person was roaming aimlessly at Charida More without mask or its alternative. I detained him. On being asked the above noted person disclosed his identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above person violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained person is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
