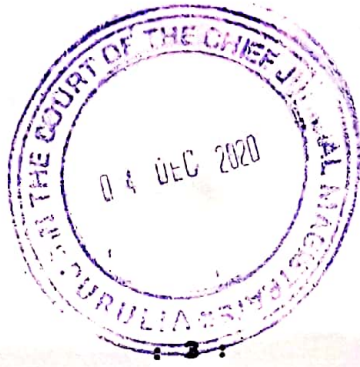

- 1.) That the Complainant is a permanent resident of Village-Marcha, P.O.Saridi, P.S. Bagmundi, Dist. Purulia.
- 2.) That the Complainant has one piece of Land at Mouza- Marcha under Bagmundi Police Station and on that Property being R.S. Plot No. 2188 ~~and~~ he has one Chala Ghar with Asbestors roof. One 8.9.2020 i.e. 22nd Bhadra at about 9.00 A.M. while the Complainant was Staying near at his said Chala Ghar at that point of time the accused persons namely Arjan Singh Mura, Thakur Sing Mura both Son's of Late Kanai Singh Mura, Poulami Singh Mura W/O, Arjan Singh Mura, Satyajit Singh Mura S/O, Arjan Singh Mura, Archana Singh Mura W/O, Thakur Singh Mura, Mangal Singh Mura, Durga Charan Singh Mura both Son's of Late Tanu Singh Mura, Padma Singh Mura D/O, Late Tanu Singh Mura all are residents of Village- Marcha, P.O.Saridih, P.S. Bagmundi District- Purulia being armed with Lathi, Sabal, Iron Rod, Etc. gherawed the Complainant and said Chala ghar and try to damage and demolished the said Chalaghar and when the complainant raised those accused persons for their illegal work all the accused persons started giving various threats to words the complainant with dire consequencps they damaged/ demolished the complainant chala ghar by their force.

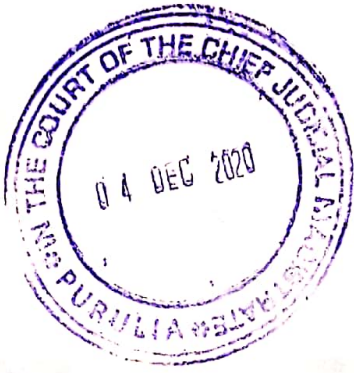
3.) That the Complainant tried to resist them and also requested not to demolish the Chala Ghar but all the accused persons damage the enter chala ghar and also damage Asbestors.

Baghmundi Police station and the Police Officer assured the Complainant that appropriate legal action would be taken against them but unfortunately till to day no action or no any specific case has yet been started against the accused persons and the accused persons still threating in Various way.
