
Since after six months of marriage and lastly on 29.10.2020 at about 02:00 P. M.

#### F. Place of Occurrence:

At the house of the accd. persons at village & P.O. - Khairachatar, P. S. – Kashmar, District - Bokaro, and at the house of the complainant at Balarampur Old Hospial Para, P.S. Balarampur, District – Purulia.

The above name complainant begs to state as follows:-

- That your complainant and witnesses residing under P.S.-Balarampur, Dist.- Purulia and the place of occurrence is under P. S. – Balarampur, District – Purulia and within the jurisdiction of this Ld. Court.
- 2. That your petitioner was married with one Salman Ansary, S/O Hakim Ansary, resident of Village & P.O. Khairachatar, P.S. Khasmar, District Bokaro (Jharkhand) on dated 05.10.2015 corresponding to 17<sup>th</sup> day of Aswin 1422 B.S. as per Muslim rites and customs prevalent in their society.
- 3. That after solemnization of marriage the accd No 1 took your petitioner to his residential house at village & P.O. Khairachatar, P.S.-Kashmar, District Bokaro (Jharkhand) and started to live there as husband and wife.
- 4. That at the time of marriage the father of your complainant was compelled to give a some of Rs 40,000/- as dowry two "Bhories" of gold ornaments and four "Bhories" of Silver ornaments, valuable utensils and furniture's all of approximately of Rs 2,50,000/(Rupees Two Lakhs and fifty thousand) to the accd no 1 as per demand of the accd. persons.



- 5. That after expiry of six or seven months of peaceful matrimonial life the accd. No 1 and his family members started demanding further dowry of Rs 60,000/- from your petitioner with an excuse that the accd. no 1 intends to set up a business.
- 6. That on this your petitioner stated that her father is a poor and financially handicapped personality and at the time of marriage a sum of Rs. 40,000/ cash one wrist watch, Gold and silver ornaments which approximately of Rs.2,50,000/along with utensils was provided to the accd. No 1 as per demand. And now at present petitioner's father is in capable to provide any further dowry. At this the accd. Persons became furious and assaulted your petitioner with fist and blows and drove her out from her matrimonial house on dated 20.03.2020.
- 7. That reaching at the father's house at Balarampur old hospital Para P.S. Balarampur, District Purulia your petitioner narrated or explain the entire facts to the members of her father's house and prayed for money as demanded by the in laws but they showed their unable ness.
- 8. That lastly on dated 29.10.2020 at about 02:00 P.M. all the accd. persons came to the house of your complainant at Balarampur and stated to abuse your complainant with filthy languages at this your complainant raised objection but the accd. persons become with fist and blows with a demand of further dowry. At this your complainant started to cry and hearing the cry alarm the witnesses and neighbor come out and the accd persons fled away.
- 9. That thereafter your complainant went to the local P.S. at Balarampur for reported the incident against the above said accd. persons but due to reason better known to the police official of the said P.S. did not take any action of the said complain.



- 10. That thereafter on 05.11.2020 your complainant informed the matter to the Superintendent of Police of Purulia but till today not any action has been taken by the police against the accd. persons. So your complainant compelled to take shelter before your Honours Court.
- 11. That the accd. person have committed the offence and they are liable to be punished accordingly.
- 12. That your complainant is a poor financially distressed lady and she is not in position to pull or conduct of the complain case in her own expenses for all such reasons the police case is desirable.

It is therefore prayed that your Honour may graciously be pleased to control the situation and unfold the truth, this complain petition may kindly be sent to the officer-in-charge of Balarampur P.S. to treat this written complain as F.I.R. and to investigate the same U/S-156(3) Cr.P.C. for the ends of justice and prosecute the accd. as per law.
