Sir.

With humble submission I would like to state that I do hereby lodge complaint against the owner of MR shop at Keshargarh SKUS and owner and driver of the vehicle (Tata Zip-XL) bearing regn. No WB 55A/7278. The fact of the case in brief is that on 22.11.2020 at 18:35 hrs O/C Hura PS received a telephonic information that some people of Keshargarh village detained the above noted vehicle loaded with PDS articles near Keshargarh SKUS. This refers to Hura PS GDE No 873 dated 22.11.2020. After receiving the information O/C Hura PS directed me to work out the information. Myself along with force reached near Keshargarh SKUS and found that a blue colour Tata Zip-XL vehicle is surrounded by local agitated villagers. After searching it is found that the said vehicle was loaded with 6 bags of wheat grain, out of which on 2 as" Bharatiya Khadya Nigam, Food Grains Commodity Wheat/Rice/Paddy, FCI-RA-2019-20, Food Corporation of India". On 4 bags marked as "Govt. of Haryana, Crop Year 2019-20, Commodity Wheat". It was also found that 5 ½ bags loaded with Atta marked as "PHH ATTA Shree Krishna Atta Mill, Telkalpara, Purulia". The local villagers claimed that those were PDS articles loaded feom MR Shop at Keshargarg SKUS and was dispatching to other place by illegal means. Hence I have taken the said vehicle in safe custody and brought to PS for proper verification. This refers to Hura PS GDE No 877 dated 22.11.2020. After that O/C Hura PS send letter to District Controller, Food and Supply, Purulia for physical verification of those articles loaded in the vehicle bearing regn No. WB 55A/7278 and to opine whether those are PDS articles or not and from where these were loaded and whether there was any anomaly behind the incident. District Controller, Food and Supply, Purulia in his letter vide Memo No 2074/DC/FS/PRL/2020 Dated 25.11.2020 informed that Atta loaded in the above noted vehicle certainly hailed from PDS and loading of PDS commodity seems to be appears from Keshargarh SKUS and from physical enquiry it is found that due to avoidance of E-POS utilization it seems to be appears anomaly regarding the same. Hence I seized the vehicle bearing regn. No WB 55A/7278 loaded with PDS articles noted above under proper seizure list in presence of witnesses duly signed by the witnesses.

Therefore I pray before you that necessary legal action may kindly be taken regarding the above noted fact.
