Sir,

We would like to inform you that one Mr. Kundan Kumar, s/o. Satish Chandra Choudhary, permanent resident of VII + P.O. Pataily, Dist: Samastipur, Bihar, as well as Flat No. 101, Pearl Exotica Apartment, Jagjivan Nagar, Dhanbad, Jharkhand was appointed as General Manager - Production in our Samarth Fablon Pvt. Ltd., and was entrusted with full responsibility of running the day to day operation of the manufacturing activities of our Plastic Packaging bags units established at VII: Baragram, P.O. Jhalda, Dist: Purulia, West Bengal.

Apart, his wife Mrs. Rinky Kundan, was also engaged as Manager, at our Hill View Resort, at S.G. Jalan Road, Ward No. 5, P.O. Jhalda, Dist: Purulia.

Accordingly, he was provided with a fully furnished two bedroom living quarter at Adersh Apartment, Hotel Hill View, S.G. Jalan Road, Ward No. V, P.O. Jhalda, Dist: Purulia, in which he was residing alongwith his family consisting his wife & two children.

However, all on a sudden, we observed that Mrs. Rinky Kundan applied for a leave of one month from the date 01.12.2020 to 30.12.2020 on medical ground and without proper communication and approval Mr. Kundan Kumar also left the factory and residential quarter simply putting a leave application for 04.12.2020 to 20.12.2020 citing the reason of health issue of his wife.

On further enquiry it is observed that Mr. Kundan Kumar has not only left Jhalda, without any proper approval of his leave as per standard operating procedure of the factory, but has removed a considerable item likes Air Conditioners, beddings, tables, chairs etc. which were provided for his use in the living quarters provided by the company alongwith valuable and important documents relating to the company with an amount of Rs. 6.40 Lac kept with him for day to day operation related expenses.

We have contacted him over phone yesterday on 05.12.2020 and enquired him about sudden departure to which he informed that due to medical reasons he had to left and when we asked about the files and cash and suggested him that before leaving he should have handed over the same to some responsible in the factory to which he informed that he will do the same in next few days.

Since, our CMD, Mr. Bishnu Kumar Agarwal is not able to attend the office due to health problems, we like to inform the entire matter to your kind self to safeguard the interest of the company, which may kindly be put in record with your kind self.

We will revert back with an update once we get more clarity in this regard as well as once our CMD is able to join the day to day operation of the factory.
