Most respectfully sheweth:-

1. That the petitioner and the above named accused persons are residing at Jhalda Town, p.s. Jhalda Dist. Purulia is within your honour's jurisdiction.

3. That your petitioner has married with Rakhi Sutradhar in the year 2011 as their customs and rites and they have two sons namely Kusha Sutradhar and Nisha Sutradhar.

They are not willing to live Rakhi Sutradhar with your petitioner as husband and wife.
7. That in the year 2015 your petitioner informed the matter to the commissioners ward no. 1 and ward no. 2 in the Jhalda Municipality for solve the dispute between your petitioner and his wife Rakhi Sutradhar and her family members.

That on 20.06.2015 held a meeting for compromise the dispute between your petitioner and his wife and ~~xxx~~ family members of Asit Sutradhar in presence of ward commissioner and other gentelment of the locality and settled that Rakhi will live with your petitioner as husband and wife peacefully and they are never quaralled against ^{each other} ~~st~~. On the basis of settlement your petitioner on 21.06.2015 went to his father-in-law house from back Rakhi to his house and Rakhi come back the house of your petitioner and living with your petitioner as husband and wife.

11. That Rakhi leave the place of your petitioner and living with her father, mother, brother and sister.

12. That your petitioner informed the matter before Jhalda p.s. but Jhalda p.s. police ~~but police take~~ no action against the accused person.

13. That the above named accused person given threated to your petitioner for dire consequence.

13. That your petitioner is a ^{very} ~~my~~ poor person ~~she~~ he has no capacity to ~~run~~ running the ~~complainant~~ ^{ant} complainant case against the accused person.

14. That the accused persons named above have committed offence punishable u/s. 147/504 I.P.C. and 307 and 120 I.P.C.
