I, ASI Ram Nath Gorain along with force return to PS and brought under seizure 01(One) seized Tractor having its registration No- (i) WB 55A 6291 is attached with a sand loaded trolley and lodged this complaint to the effect that on 21.12.2020, I along with force C/1032-Kazi Kedar Rosul, C/2275-Sandip Rana, C/2803-Uttam Kr. Roy were performing night mobile duty as per order, vide Tulin OP CC No- 2330/2020, Dt-21.12.2020. During Night mobile duty & on 22.12.2020 at morning time about 07:15 hrs received a credible source information that some owners of the tractors were extracting sand illegally at Subarnarekha river near Barghutuya village and Subarnarekha River Bridge. Accordingly, myself along with force left to work out the said source information. Then, we intercept the aforesaid vehicle near Subarnarekha river Bridge at Barghutuya village under Jhalda PS at about 07:45 hrs and found the above noted tractor was tagged with a trolley loaded with sand. But seeing the Police Party driver of Tractor and others fled away leaving his Tractor with sand loaded trolley on road. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. So there is every ground to reason to believe that the owner, driver and others of above noted Tractor dealing in sand business in clandestine manner and they do not have any proper challan or any documents related to the said loaded sand of above detained Tractor. So I, seized above noted Tractor having its registration no WB 55A 6291 with attached sand loaded Trolley (approx 100 cft)

On return to Jhalda P.S, kept the aforesaid sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Owner and Driver of the Tractor having its registration no WB 55A 6291 & others under proper section of law.
