STATE OF THE STATE

The above name complainant begs to state as follows:

- 1) That the complainant is the legally married wife of the accused person no-1 Kanchan Sardar and their marriage was solemnized on 25/06/2020 with the said Kanchan Sardar as per Hindu Rites and Customs as prevalent in our community and also by observing the formalities like putting on vermilion, exchange of garlands, Home etc and the said marriage is still subsisting.
- 2) That at the time of marriage as per demand of the above noted accused person father of the complainant had to pay a cash of Rs. 50,000/- and one Motor Bike, Utensils, furniture, etc. After marriage the complainant was taken at her matrimonial house and the complainant started her matrimonial journey with her husband and other inmates of the family.

After few days T came at my paternal house for observing Astamangala Ceremony, thereafter the complainant was again went to her matrimonial house and stayed therein and was leading her conjugal life.

In course thereof, the complainant to her utter surprise noticed that the husband of the complainant has illicit relationship with a girl and her photography etc was in the mobile of the husband of the complainant which the complainant have seen in course of her staying in the house of her husband.

That after few days' behavior of the husband of the complainant and other in-laws became changed which socked her very much, but the complainant somehow passing her days for good days and on the hope that her matrimonial life would be as well as good and normal after of course passage of time.

However, in course of the staying of the complainant at her matrimonial house none of the in-laws of the complainant including the husband of the complainant did not love her, not provided her proper food and clothing even assaulted the complainant mercilessly without any fault on her part.

In course thereof the husband of the complainant and other in-laws demanded a further cash at least of Rs.30,000/- to be paid by the father of the complainant, contrary to that the accused person will not allowed to stay in their house as they disclosed it before the complainant.

The complainant thereafter, reported all the incident to her parents and other inmates, when such illegal demand was not fulfilled then all the above noted accused person continued persistent torture upon the complainant which gradually unbearable for the complainant.

4) That in such circumstances one meeting was held when the above accused person pleaded their guilty and also promised before all that they will not inflect any such torture upon the complainant in future, rather they will keep the complainant with proper prestige and care including providing other daily necessities. But they did not keep their promise, but renewed their old habit till the complainant was at her matrimonial house.

That on 01/11/2020 corresponding to 15th Kartik 1427 BS all the above noted accused person assaulted the complainant mercilessly and asked the complainant for divorce contrary to that the accused person will kill the complainant.

However, to save the life of the complainant, she somehow managed to come at her paternal house with the above noted accused person driven out the complainant from the house of the accused person and since then the complainant is staying at her paternal house
