In producing herewith one accused person namely Makhan Kumar (25) s/o Gurupada Kumar of vill.- Chekya, PS- Kotshila, Dist.- Purulia I along with one motor cycle styled as Hero Splendor+ "Black Colour having no number plate (Engine No. HA11EYLHJ65530 and Chassis No. MBLHAW123LHJ24563) as per seizure list. I ASI Joydip Singha of Kotshila PS beg to state that today on 15.12. 2020 at 16.45 hrs, while I alongwith C- 315 Mir Kurban and C- 1189 Suchand Hansda were engaged in Naka Checking duty at Talli Centre More under Kotshila PS and we were trying to stop and check one motor cycle coming from Jhlada side to Kotshila side on Purulia-Ranchi Road on SH-4A in which two persons were boarded and after noticing Police from near away they stopped their motor cycle and tried to fled and after short chase we could apprehend one of them but the other one manageed to flee away from that place. On asking he disclosed his identify as Makhan Kumar s/o Gurupada Kumar of vill.- Chekya, PS- Kotshila, and stated that he was pillion rider of the motor cycle. After apprehending I also asked him to produce valid papers in respect of above noted motor cycle having no number plate, but he could not produce any valid papers against the said motor cycle and could not provide any satisfactory reply. On further interrogation he confessed that they have stolen that motor cycle and name of the rider is Sk Sajjad s/o Sk. Ajad of vill.- Kantadih, PS- Jhalda, Dist.- Purulia and going to sell this. Further he also revealed that he along with Sk Sajjad and some others are habitually dealing in stolen property since last few years.

Accordingly I seized the motor cycle styled as Hero Splendor+, Black Colour having no number plate (Engine No. HA11EYLHJ65530 and Chassis No. MBLHAW123LHJ24563) after preparing proper seizure list duly signed by accused person and a company police persons because the local people refused the sign in seizure list.

In accordance with the law and adhering all guidelines regarding arrest, I arrested the accused Makhan Kumar (25) s/o Gurupada Kumar of vill.- Chekya, PS- Kotshila, Dist.- Purulia.
