In producing here with arrested accused persons namely (1) Md. Abdul Sahid (37) S/O- Lt. Md. Jubed Sahid of Niyamatpur Chakraborty Para and (2) Bhola Shaw (30) S/O- Shree Shaw of Niyamatpur Municipality Road both under PS-Kulti, Dist-Paschim Bardwan (3) Ajoy Pandey (20) S/O- Raju Pandey of Neturia (4) Prithwiraj Pandey @ Mona (32) S/O- Subrata Pandey of Neturia (5) Mona Dubey (21) S/O- Surajit Dubey of Neturia and (6) Rohit Sen (21) S/O- Kapileshwar Sen of Bartoria all are under PS-Neturia, Dist-Purulia; to the effect that today 03.12.2020 at about 22.15 hrs received credible source information vide Neturia PS GDE No-135 Dt. 03.12.2020 that a gang of criminals being armed with deadly weapons assembled at Dubeswari football ground with a Maruti car and preparing themselves for committing dacoity on Purulia - Barakar road upon running vehicles, accordingly I informed the matter to you and as per your direction I, SI Bablu Ghosh accompanied with PSI Abhijit Das, C/1140 Dayamoy Mahato, C/1304 Dhananjoy Mondal and C/1303 Biswanath Majhi & others all of Neturia PS immediately proceeded to the anticipated place of assembly to work out the information and reached at 22.20 hrs near the anticipated place and noticed that 07/08 persons assembled at Dubeswari ground and those persons are whispering for preparing themselves to commit dacoity upon running vehicles on Purulia - Barakar Pitch road as it could be audible from the talks of the assembled criminals. Then after disclosing our identity, I commanded them to surrender but they paid no heed to it and started to run away. We succeeded in rounding up only 06 (Six) of them while the rest 02 escaped away despite hot chase after them. I asked them for their presence at night hours but they failed to give any satisfactory answer. We searched the above noted accused persons and recovered one knife length approx 10 inch from the left side waist of accused Md. Abdul Sahid and after searching of the vehicle having registration No- WB 82A/4220, found 02 (Two) iron rod and one Lathi (Bamboo). It is strongly believe that the above noted accused persons and others assembled there for preparation of Dacoity upon vehicle on Purulia- Barakar pitch rod. Then, I arrested them and seized one knife, two iron rods, one Lathi and one Maruti car (Details mentioned in the attached seizure list) under proper seizure list duly signed by arrested accused persons and witnesses. On interrogation arrested accused persons stated that they have assembled there for committing road dacoity but they could not say about the name of other co - accused persons. During search and seizure no public witness available there. During arrest maintained all formalities regarding arrest and informed ground of arrest.

Therefore, I pray that a specific case may kindly be registered against arrested accused (1) Md. Abdul Sahid (37) S/O- Lt. Md. Jubed Sahid of Niyamatpur Chakraborty Para and (2) Bhola Shaw (30) S/O- Shree Shaw of Niyamatpur Municipality Road both under PS-Kulti, Dist-Paschim Bardwan (3) Ajoy Pandey (20) S/O- Raju Pandey of Neturia (4) Prithwiraj Pandey @ Mona (32) S/O- Subrata Pandey of Neturia (5) Mona Dubey (21) S/O- Surajit Dubey of Neturia and (6) Rohit Sen (21) S/O- Kapileshwar Sen of Bartoria all are under PS-Neturia, Dist-Purulia along with 02 others unknown under proper section of law.
