Respected Sir,

In producing herewith seized articles i.e. 1) Some bricks, 2) Some stones, 3) three lathi and 4) some broken glass under proper seizure list duly signed by the witnesses.

I would like to draw your attention that as per detailment I along with force 1) C/140 Subrata Banerjee, 2) C/2516 Arup Mondal, 3) C/2054 Arunavo Palmal, 4) C/2106 Mithun Dey, 5) C/2570 Barun Sen, 6) C/2127 Rupen Pradhan, 7) C/2182 Md. Safiul Khan and CVF were performing Police Picket duty (Morning shift 06.00 hrs to 14.00 hrs) at Malanchadi village as a tension is going on there over the issue of a incident of stabbing of a minor girl of that village by a youth of adjacent village Patpur.

At around 08.55 hrs. I noticed that a good many villagers are getting assembled at a place from deferent Paras. I approached to them and tired to know the reason of the assembly but they did not entertain me. I went back to our post and briefed our men apprehending that the mob may cause law & order problem.

All of a sudden the mob of about 400-500 villagers including female being equipped with lathi, Iron rod, bricks, stones started approaching towards us with unruly manner. They reached at us and started abusing us with filthy languages demanding the withdrawal of Police force from there. I tried to pacify them but none of them pay any heed to me. Among the mob I personally know 1) Manpuran Gorain S/o Lt. Rajendra Gorain, 2) Santanu Gorain S/o Manpuran Gorain, 3) Milan Duary S/o Lt. Ananda Duary all of Vill- Malanchadi since long and accordingly I approached them to control the mob but they inspite of controlling the mob started instigating it to harass Police force.

I informed you the matter for re-enforcement and I along with my forces tried our best to tackle the situation. I with the help of local CVF could identify 1) Subhamoy Majee S/o Asit Majee, 2) Dinesh Duary S/o Jaladhar Duary, 3) Kanai Gorain S/o Jagabandhu Gorain, 4) Shyam Majhi S/o Not noted all of Vill- Malanchadi, PS- Para, Dist- Purulia who were leading the mob from front.

In the meantime ASI Tarun Bhui & force reached there and they also joins to overcome the situation. But suddenly the mob started shouting and pelting stones at us and as a result three Police personnel got injury later on they treated at Para BPHC. In the meantime you with force came and we together chase the mob and they fled away.

Hence they have committed the offences come under the ambit of U/S- 147/148/149/151/186/188/353/332/333/323/325/427/506 IPC & 3 P.D.P.P. Act.

Under the above fact and circumstance I therefore pray that a case u/s 147/148/149/151/186/188/353/332/333/323/325/427/506 IPC & 3 P.D.P.P. Act. may kindly be started against 1) Manpuran Gorain S/o Lt. Rajendra Gorain, 2) Santanu Gorain S/o Manpuran Gorain, 3) Milan Duary S/o Lt. Ananda Duary, 4) Subhamoy Majee S/o Asit Majee, 5) Dinesh Duary S/o Jaladhar Duary, 6) Kanai Gorain S/o Jagabandhu Gorain, 7) Shyam Majhi S/o Not noted and 400 others all of Vill- Malanchadi, PS- Para, Dist- Purulia and arrange for its investigation.
