





5. That after admission, on that very day, husband of the complainant died in the evening.
6. That the complainant could not lodge the complaint in time as the complainant mentally broke down and for her husband's funeral function.
7. That the complainant went to the Para Police Station on to lodge this written complaint where the concerned police officer informed the complainant to take shelter of court.
