Sir.

I ASI Partha Sarathi Murmu of Purulia (M) PS. Dist-Purulia do hereby lodge a suo moto complain after arriving at PS that today 04.12.2020 I along with force was performing special mobile duty at PS area by Purulia (M) PS GDE No-156 dtd- 04.12.2020 and in consonance with CC No-3177/2020 dtd-04.12.2020 received a telephonic information from duty officer of Purulia (M) PS regarding a bike rally of about 40 (seventy motorcycle) was proceeding from Chasmore towards Purulia Town by obstructing National Highway (NH-32). Immediately after receiving the information I along with force rushed towards Chasmore after being instructed by I.C Purulia (M) PS with Govt, vehicle WB56C/8742. As soon as I arrived at Imundih more at about 13.15 hrs. I found that bike rally consisted of 35 to 40 bikes, almost all bike with their pillion rider most of them without any helmet were going towards Purulia Town. I also found that rally was going covering the entire the National Highway (NH-32) with their party slogan with flag. I tried to stop them to demand any valid permission of that rally but none of the members of rally stop their respective bike and disobeyed my ordered and refused to give information. It could be presumed that the rally had been conducted without permission under the leadership of (i) Satyagopal Mukherjee of Lagda (ii) Gayaram Pandey of Chirka (iii) Kunal Goswami of Chirka (iv) Raghunath Pandey of Chirka (v) Bankabihari Mahato of Chirka (vi) Laltu Mahato of Chirka (vii) Haraprasad Mahato of Garaphusra (viii) Indrajit Mahato of Garaphusra (ix) Biplab Mahato of Ranibandh (x) Dipak Mahato of Sindri (xi) Biswajit Mahato of Sindri. The vehicular traffic was almost disrupted along the Purulia-Ranchi road (NH-32). Thereafter, I informed the matter to I.C Purulia (M) PS and he also confirmed me the rally was being conducted without any valid permission from proper authority. Afterwards, I found that some of vehicles which were running slowly just like a tortoise motion after the rally. Subsequently I diverted some of those vehicles towards the bypass road to avoid congestion along the National Highway as the road is one of the busy public lines of navigation of this district. Latter, while the rally arrived at Purulia Town at about 15.15 hrs the vehicular traffic movement became normal after our assiduous act. As the members of the rally committed offence u/s 283 IPC & 18 W.B Highway Act. 1964 & read with section 32 Police Act 1861 & 179 (1)/177/129 of Motor Vehicle Acts 1988 under the leadership of supra noted persons ergo, I submitted suo moto complain before your good self to started specific case against them.
