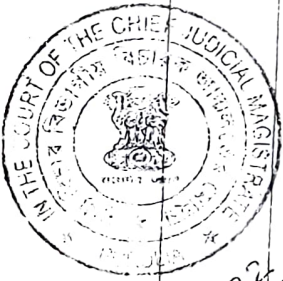

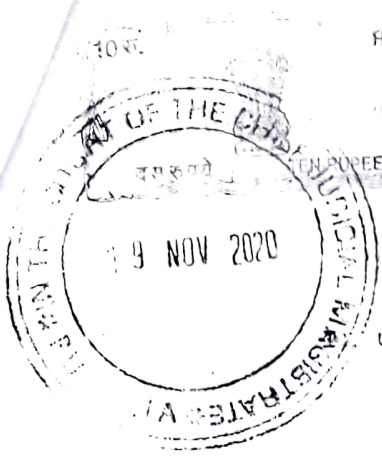

Complainant named above begs to as follows:-

1. That the complainant has a landed property situated at mouza ~~Sandhu~~ ^{Andhuli}, J.L.No.127, L.R.Khatian 20.55, L.R.Plot No.44, and the complainant has exclusive right, title and possession over the said land. L.R.record of right has been prepared in the name of the complainant.
2. That the complainant has transplanted about 200 sonajhuri trees over the aforesaid land ~~at~~ for about 13/14 years ago and those trees have been deolved and grown at large.
3. That on the date of occurrence i.e. on 20.7.20 accused persons at about 09.00 A.M. the complainant has came to know that from the witness no.2 that all above named accused persons are cutting the sonajhuri trees of the land of your complainant, immediately the complainant rushed to the P.O. on plot no.44 of mouza ~~Sandhu~~ ^{Andhuli} and so that the accused no.1, 2, 3 and 4 with some labours are cutting sonajhuri trees from the complainant and accused no.4 is helping them and they were loading the logs of cut trees on the tractor of accused no.4 to which the complainant raised objection against the accused persons but the accused persons of the jurisdiction committed an assault on the complainant.

4. That the accused persons have cut 60 trees and taken the cut trees to which the complainant sustained a loss of Rs.60,000/- approx.
5. That the accused persons have got no right, title over the aforesaid plot but they are dangerous and desperate in nature having no regard of law.
6. That the complainant lodged F.I.R. before Purulia (M) P.S. the police has assured to start case against the accused but no case hask been started till date so, the complainant lodged complaint before the S.P. Purulia but S.P. also has not taken any lawful step and so, this complaint.
7. That the complainant is very poor man and it is not possible for him to engage private lawyer day after day to prosecute case and hence this case.

It is therefore prayed that your honour would be pleased to send this petition to the O.C. Purulia(M) P.S. treating this F.I.R. as per sec.156(3) Cr.P.C.
