

5. That the accused persons have got no right, title over the aforesaid plot but they are dangerous and desparate in nature having no regard of law.
6. That the complainant lodged F.I.R. before Purulia (M) P.S. the police has assured to start case against the accused but no case has been started till date so, the complainant lodged complaint before the S.P. Purulia but S.P. also has not taken any lawful step and so, this complaint.
7. That the complainant is very poor man and it is not possible for him to engage private lawyer day after day to prosecute case and hence this case.
