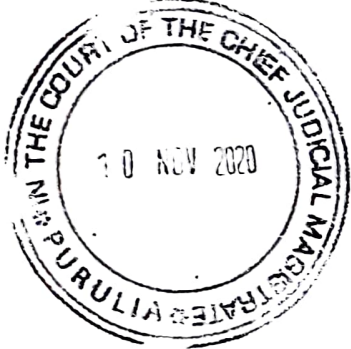

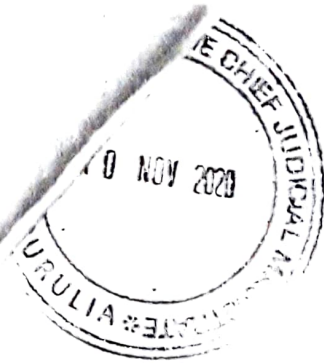

1. That the complainant, accd persons and witnesses are resident of Vill. Balarampur, P.S. Purulia(M) Dist. Purulia.
2. That on 29.10.2020 corresponding to 12th day of Kartick 1427 B.S. at about 7.00 P.M. when the complainant was going to purchase domestic food materials, Then the above named Accd persons armed with weapons like iron rod, Lathi etc and they started abusing the complainant. Then the complainant protested the illegal acts of the accd persons, but they did not pay any heed to the request of the complainant. All on a sudden the accd. persons No-2 (Pasupati Sardar) caught hold the ^{complainant} ~~complainant~~ from his back side and ^{snatched a sum} ~~accd No-1~~ ^{from his pocket of complainant} ~~from his pocket of complainant~~ ^{Supplies} ~~Supplies~~ ^{Two Thru} ~~Two Thru~~ Gouranga Sardar assaulted the Fore-head of the complainant by lathi as a result of which the complainant sustained bleeding injury and fel down on the ground, hearing the shout Deepankar Sardar the nephew of the complainant came there to save the complainant then accd No- 1 Gouranga sardar assaulted the said Deepankar Sardar by Lathi on his back side. Then the Deepankar sardar makes a noise by saying ⁱⁿ ~~in~~ ⁱⁿ ~~in~~ Bachow- Bachow, ⁱⁿ ~~in~~ ⁱⁿ ~~in~~ Hearing the noise the witnesses came there and save the complainant and his nephew from the hand of the accd persons. then the accd persons left the place with dire consequence.

3. That there after the complainant and his nephew went to purulia (M) P.S. and reported the matter of the duty office of Purulia(M) P.S. and went to Purulia Sadar Hospital for treatment. And after seeing the condition of the complainant admitted him as in door patients and after treatment discharged him on 30.10.2020

4. That there after the complainant came to learn P.S. concern not to take necessary steps then the complainant informed the matter to S.P. Purulia but off no good. Now for geting appropriate / relief the complainant file this case for proper legal action.

5. That the accd persons have committed offence and they are liable to be punished accordingly.

It is therefore prayed before your honour would be pleased to direct the officer-in-charge Purulia (M) P.S. for investigation of the case against the accd. persons by treating this complain as F.I.R. provided U/s 156 Cr.P.C.
