

Sub: Request for lodging F.I.R. against accused persons Babu Sao and Nayan Mallick.

Sir,

I SI Maniur Rahaman of Purulia (T) PS do hereby lodged complaint against Babu Sao s/o Sanjay Sao of Old Police Line, Usman Gali, PS-Purulia (T), Dist- Purulia and Nayan Mallick S/O-Radha Mallick of Kadamkuli, PS-Purulia (T), Dist-Purulia that today (15.12.2020) at about 09:45 hrs, I have received an information from an unknown caller that said Babu Sao posted regarding Love Jihad matter in Facebook page Rashtriya Bajarang Dal Purulia-W.B' malignantly, which is illegal and gives provocation to any person intending of knowing it to be likely that such provocation will cause the offence of rioting to be committed in consequence of such provocation. He also shared this post on his another Facebook page 'Kattar Hindu Babu'. Accused person Nayan Mallick shared this post with others on his Facebook account with the same intention. Thus insulted the common people intentionally and circulated false information among the people through social media (Facebook) and thereby gives provocation to break the public peace and having conspired with others facebook sharers tried to commit communal riot in the society or to commit any other offence throughout the society fully neglecting the Govt. order during this pandemic situation.

Accordingly I go through the Facebook page of him taking help of witnesses and verified the complaint and found it to be authenticated. Then I took screen shot of those pages and also made print out of those pages which are attached with this complaint. I held raid at houses and possible places of Babu Sao and Nayan Mallick and arrested Nayan Mallick from Daserbandh More under Purulia (T) PS after observing all formalities regarding arrest. But Babu Sao evade himself to avoid Police arrest.

On return to PS, I lodge complainant against above noted accused persons for starting a case U/S 188/203/153/504/120B IPC. & Sec 51 of National Disaster Management Act. 2005, and also for arranging for its investigation.
