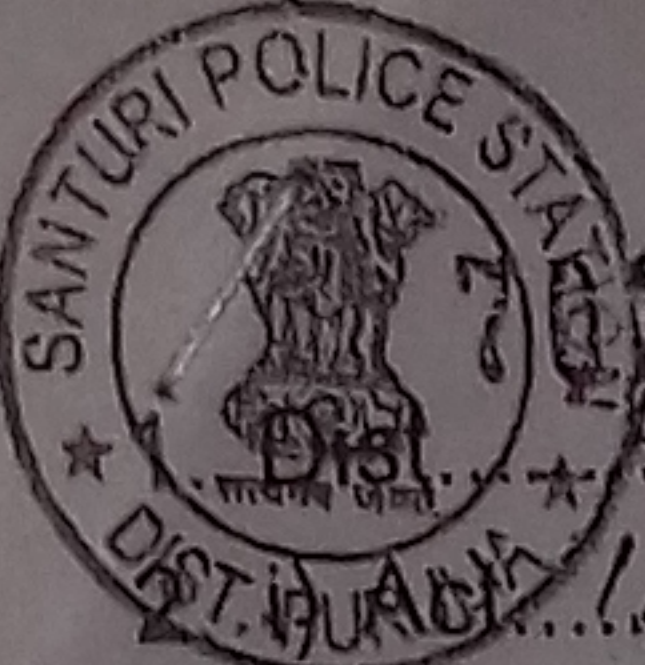

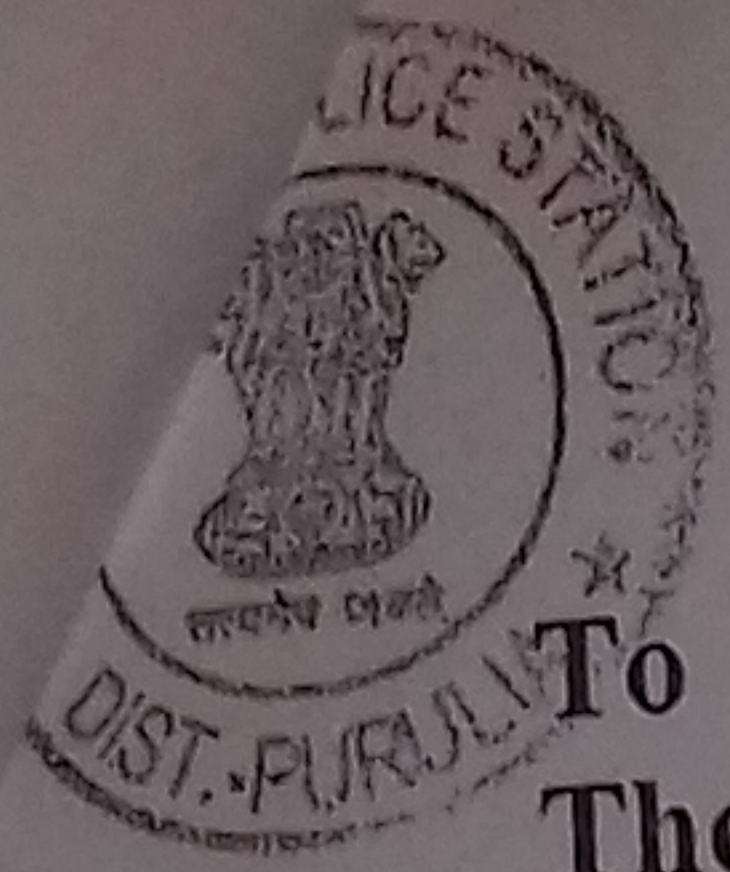

Sir,

With due respect and humble submission, I beg to submit that today i.e, on 30.11.2020 at 10:45 hrs. while I ASI Gurucharan Sahis along with C/1424 Bhairab Patra and C/1485 Swarup Nandi both of Santuri PS were performing day time mobile duty at Jagannathdi Morh received a credible source information that one Sk Abdul @ Sarka of village Murulia P.S Santuri, Dist. Purulia in connivance with owner and driver of tractor bearing Registration No. WB 39/TC-A/8 transporting illegal coal to run a clandestine business for wrongful gains from Jadurdih to Madhukunda side. After getting such information, I alongwith force left Jagannathdih village to work out the aforesaid information on getting your kind permission. Near culvert in between Mark Steel and Jagannathdih village on Jagannathdih- vetti road through Mark Steel found one tractor is coming loaded with some articles. Seeing the police party they started to flee away after keeping the tractor on that spot i.e on road. I have called to Sk Abdul @ Sarka of Murulia by name but he did not care and they all fled away ignoring my call. During enquiry, it is transpired that these persons have been procuring and accumulating the said coal by means of theft or any fraudulent manner by illegal business and habitual to run this business. So, I have seized the aforesaid tractor bearing Reg. No. WB 39/TC-A/8 with 08 M.T coal (2) 02(two) pieces of iron made Belcha (3) 03(three) pieces of Basket (4) 02(two) pieces of spade under proper seizure list duly signed by the available witnesses. I have also sealed & labeled approx 01 (one) K.G coal as sample from the major contraband on that spot Thereafter arranging a public driver I brought the seized Tractor with Coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against Sk Abdul @ Sarka of Murulia , owner and driver of the tractor bearing Reg. No. WB39 /TC-A/8 having Engine No. 3100DL83A699757F3, Chassis No. MZQSG708809SM under proper section of law.
