
With due respect and humble submission, I beg to submit that I ASI Manaranjan Singh Sardar along with C/1052 Shyamlal Murmu and NVF/717 Haren Ch. Mahato all of Santuri PS while performing mobile duty on 13.12.2020 at 03:45 hrs received a credible source information that a tractor bearing registration No. WB55B-2514 (3032 New Holland Plus, Blue colour) loaded with coal which has been procured by means of theft or any fraudulent manner is proceeding towards Mokra village side from Jadurdi village through Jadurdi to Mokra kaccha road. After receiving the said information we have started NAKA checking duty near Mokra Bauri Para Hari Mandir under our P.S jurisdiction with a view to intercept the said vehicle. At about 04:25 hrs we found the aforesaid vehicle is coming from Jadurdi village side and seeing police party at near Kali Mandir the driver of the said vehicle flee away by stopping the vehicle on road. We have tried to apprehend the driver but failed. On reaching near said tractor I along with my accompanying force searched the vehicle and found that the Tractor was carrying 08(Eight) M.T (approx) coal. No such document could be found in respect of said coal loaded Tractor. It is reasonable to believe that the owner, driver of said vehicle bearing Regn No- WB55B-2514 (3032 New Holland Plus, Blue colour), Engine No. S324F07286, Chassis No. NHN30320ZKK488102 and others collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. So, I have seized the said Tractor (bearing Regn No- WB55B-2514 (3032 New Holland Plus, Blue colour), Engine No. S324F07286, Chassis No. NHN30320ZKK488102 under proper seizure list. I have also sealed & labeled approx 01 (one) K.G coal as sample from the major contraband. There was no such public witness available at the time of seizure. Thereafter arranging a public driver I brought the seized tractor loaded with coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the owner, driver of the tractor bearing Registration No. WB55B-2514 (3032 New Holland Plus, Blue colour), Engine No. S324F07286, Chassis No. NHN30320ZKK488102 and others under proper section of law.
