I SI Sourav Banerjee of Adra PS do here by lodged a complaint against accused namely Jagdish @ Modha Hela (42 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Distthe effect that on 24/01/21 at about 17:25 hrs I received a telephonic information from a reliable source that one Jagdish @ Modha Hela (42 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia has been stock of country spirit illegally at his Shop at Lower Jhariadih under Adra PS. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left the PS to work out the information vide Adra PS CC No- 253/21 dtd.24/01/21 and reached at Lower Jhariadih village at about 18:15 hrs and hold raid in the Shop of said Jagdish @ Modha Hela (42 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia and found that the said person selling liquor at his shop and after seeing the Police party some person fled away and said Jagdish @ Modha Hela has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Jagdish @ Modha Hela (42 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I therefore pray that a specific case may kindly be started against arrested accused Jagdish @ Modha Hela (42 Yrs) S/O Lt. Parma Hela of Vill- Arrah, PS-Adra, Dist-Purulia under proper section of law.
