In producing here with one arrested accused namely Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 16 bottles (in sealed condition) DIL SE country spirit, 600-ml each bottle, Rs-50/- of each bottle. (2) 02 bottles (in sealed condition) Officer Choice deluxe whisky 750-ml each bottle, Rs-490. (3) 01 bottle (in sealed condition) imperial Blue classic grain whisky 750-ml, Rs-540/- (4) 01 bottle (in sealed condition) 8 PM Smooth Indian whisky 750-ml, Rs-520/-. (5) 01 bottle (in sealed condition) McDowall's No-1 Celebration matured XXX RUM 750-ml, Rs-640/-.

I SI Sourav Banerjee of Adra PS do here by lodged a complaint against accused namely Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia to the effect that on 26/01/21 at about 18:35 hrs I received a telephonic information from a reliable source during my evening mobile duty at P.S area vide Adra PS CC NO-272/21 dtd. 26/01/21 that one Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia has been stock of country spirit and foreign liquor illegally at his Shop at Sevanagar Village. After getting such information I informed to my I/C and as per his direction I along with my accompanied force reached at Sevanagar village at about 19:05 hrs and hold raid in the Shop of said Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia and found that the said person selling country spirit and foreign liquor at his shop and after seeing the Police party some person fled away and said Shiba Mukhi has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit and foreign liquor but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist- Purulia under proper section of law.
