(3) 01 bottle (in sealed condition) imperial Blue classic grain whisky 750-ml, Rs-540/- (4) 01 bottle (in sealed condition) 8 PM Smooth Indian whisky 750-ml, Rs-520/-. (5) 01 bottle (in sealed condition) McDowall's No-1 Celebration matured XXX RUM 750-ml, Rs-640/-.

I SI Sourav Banerjee of Adra PS do here by lodged a complaint against accused namely Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill-Sevanagar, PS-Adra, Dist-Purulia to the effect that on 26/01/21 at about 18:35 hrs I received a telephonic information from a reliable source during my evening mobile duty at P.S area vide Adra PS CC NO-272/21 dtd. 26/01/21 that one Shiba Mukhi (30 Yrs) S/O Basudeb Mukhi of Vill- Sevanagar, PS-Adra, Dist-Purulia has been stock of country spirit and foreign liquor illegally at his Shop at Sevanagar Village.
