On 8th Jan 2021, post incident she was immediately
taken to Adra Rail Hospital, after initial first Aid
she was referred to Gau Devi Hospital, Durgapur,
where she is undergoing further treatment.

My mother reported this incident to me over telephone
on dt. 08.01.2021 afternoon and she narrated the
complete incident to me when I visited her.

and do lawful action
