**Sub: Complain against theft of Distribution transformer parts i.e. oil, winding & transformer core from one no.25Kva at vill- JORISA (RLI) under Adra C.C.C.**

Sir,

On dated 21/01/2021 at around 1:00pm (approx), we received information regarding the problem of a DTR at vill-Jorisa (RLI) connection. In reference to this mentioned information, our technical staff inspected the spot on 21/01/2021 and around 2:00pm (approx) reported that the oil in the transformer tank as well as DTR core and winding parts were missing and the empty DTR body was left on the ground in that damaged state. In distribution transformer there was more or less 40 to 50 liters of oil. Due to the above mentioned incident the DTR cannot be put in operation. So the consumer against this transformer is suffering from no power.

The details of the damaged transformer are mentioned below:

1. DTR Capacity: 25 kVA.
2. Make: Technical Associates Limited.
3. MFD: 05/2015.
4. Serial No. : TA252072.

Total damage property comes to the tune of Rs. 89,221.00 (approx).

So, you are requested to look into the matter and treat this letter as an F.I.R.
