Sir,

In producing here with one arrested accused namely Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 20 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-50 of each bottle.

I SI Subrata Sadhu of Adra PS do here by lodged a complaint against accused namely Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia to the effect that on 25/01/21 at about 17:35 hrs I received a telephonic information from a reliable source during my evening mobile duty at P.S area vide Adra PS CC NO-264/20 dtd. 25/01/21 that one Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia has been stock of country spirit illegally at his Shop at Kamlasthan Village. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Sevanagar village at about 18:05 hrs and hold raid in the Shop of said Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia and found that the said person selling liquor at his shop and after seeing the Police party some person fled away and said Partha Banerjee has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Partha Banerjee (42 Yrs) S/O Lotan Banerjee of Vill- Kamlasthan, PS-Adra, Dist- Purulia under proper section of law.
