In producing herewith the accused person namely Jagjiban Sing Babu (35 Yrs), S/O-Lt-Ramkrishta Sing Babu of Vill-Simali, PS- Baghmundi, Dist- Purulia along with seized articles 1) 26 ltr ID Liquor in white plastic jerican, 2) 15 (Fifteen) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 29.01.2021 during the special raid duty as per source information I along with 1. C/2992 Bikash Dile, 2. C/2669 Prabir Sinha Mahapatra both of Suisa OP under Baghmundi PS vide Baghmundi PS C.C. No- 127/2021, dtd- 29.01.2021 reached at Simali Village at 18.05 hrs and found that the above noted person is selling I.D liquor in her dwelling house at Simali village under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 46 A(c) B.E. Act. And also seized in his possession 1) 26 ltr ID Liquor in white plastic jerican, 2) 15 (Fifteen) Pcs Plastic Glasses as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 46 A(c) B.E. Act. A sample ID liquor taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 18.35 hrs. During arrest I maintained all formality of arrest rule. I offered him medical treatment but he deny.

The above noted arrested accused person namely Jagjiban Sing Babu (35 Yrs), S/O-Lt-Ramkrishta Sing Babu of Vill-Simali, PS- Baghmundi, Dist- Purulia committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
