I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Bidio Singha, S/O- Lt Lakhiram Singha of village - Kudna, P.O. - Ekra P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 25/01/2021 at about 11:10 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hasib, LM 2. Subhasis Mahato, O.E. entered the premises of Sri Bidio Singha, S/O- Lt Lakhiram Singha of village - Kudna, P.O. - Ekra P.S- Bagmundi, Dist- Purulia and found Sri Bidio Singha was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Bidio Singha S/O- Lt Lakhiram Singha committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Abdul Hasib, LM 2. Subhasis Mahato, O.E. The inspection team left the premises at 11:20 a.m.
