Sub: Complaint against Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia to start a specific case U/S- 46A(C) Bengal Excise Act.

Sir,

In producing here with one Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia under arrest and seized articles one Plastic bag loaded with 02 (Two) Rubber tube containing approx 29 (Twenty Eight) liters of ID liquors (MAHULA), 1 liter ID liquors (MAHULA) kept as sample article under seizure as per enclosed seizure list along with one red colour Motor cycle TVS XL100 Heavy Duty no any number plate, bearing engine No- MD621BP2XL1K01761 & Chassis No- P7010039.

I, SI Sajal Kanti Panda of Barabazar PS do here by lodge this complaint as against Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia that today (27.01.2021) during my mobile duty received a source information that one person unauthorized carrying ID liquor (MAHULA) from Jharkhand side towards Manpur. I have been then verified the credibility of that information and immediately conveyed the information to the duty officer PLSI Rima Patra of Barabazar PS and diarized the matter vide Barabazar PS GDE No- 1355 Dtd. 27.01.2021 at 13.55 hrs. As per direction of I.C Barabazar PS myself along with forces started NAKA checking at Sankhari bye pass morh to work out the information. At about 15.15 hrs found one person coming towards NAKA point by a motor cycle carrying with one plastic bag. We stopped him and on searching found one Plastic bag loaded with 02 (Two) Rubber tube containing approx 29 (Twenty Eight) liters of ID liquors (MAHULA). On being asked he disclosed his identity as Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia and failed to produced any supporting documents to carry the said articles. On being asked he stated that he has been carrying the same from Jharkhand side area to Manpur with intent to sell to make profit. He also admitted that he had no license or any authorization to carrying and sells. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 1 liter ID liquors (MAHULA) taken as sample from that seizure as sample which was also duly labeled and also took signature of the accompanying witness on seizer list and label. Thereafter, I secured arrest of said Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia after preparing Memo of arrest & after observing all other formalities of arrest. Informed him and his relatives regarding the ground of arrest. The arrest was made at 15.35 hrs.

Under the above circumstances I, therefore, pray before you that a specific case U/S- 46A(C) of Bengal Excise Act may kindly be registered against said Ramesh Ch. Mahato (22 Yrs) S/o- Chunaram Mahato of Village- Manpur, PO- Bamundiha, PS- Barabazar, Dist- Purulia and also for arranging its investigation.
