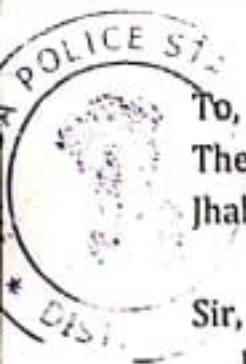

Sir,

In producing here with 02 (Two) arrested accd. persons namely 1. Kanchan @ Fuchu Tewari (27) S/O Nabakishor Tewari of Vill-Meshya, PS-Jhalda, Dist-Purulia and 2. Asish @ Ritesh Tewari (24) S/O Kumud Ranjan Tewari of do and brought under seizure i) Eight lathi of different size ii) Seventeen numbers of brick bats and iii) Three numbers of iron rods and do here by lodged this complaint against above noted 02 (Two) arrested accd. persons and others to the effect that today i.e. on 12/01/2021 at 15:35 hrs. received telephonic information from table duty officer ASI Habibul Rahaman Mandal that SI Hemanta Kr. Sahababu along with 02 (two) C.V.Fs namely Santiram Mahato and Anup Mahato went to village Meshya, PS-Jhalda for enquiry into a land disputed matter and SI Hemanta Kr. Sahababu has been assaulted and forcefully confined by some people of Meshya village. Acting on this information myself with force reached at Meshya village at about 16:15 hrs. and found SI Hemanta Kr. Sahababu is critically injured and has been confined by the above noted accd. persons. We tried to rescue SI Hemanta Kr. Sahababu but accd. persons were very aggressive and not ready to leave him and shouting that "হেমন্ত বাবুর ডেড বড়ী নীয়ে যা". After that they started assaulting him with iron rod, lathi, bricks and sword in order to murder him. Later on SI Ashok Kr. Sen and force including L.C. arrived there. We tried to understand them that they should not take law in their hand and leave SI Hemanta Kr. Sahababu. We tried to convince them in all possible ways so that they leave SI Hemanta Kr. Sahababu. But they became more furious and shouted " পুলিশকে নেবে শেষ করেছে". Then they started assaulting us with deadly weapons. Finding no alternative we started mild lathi charge and rescued SI Hemanta Kr. Sahababu in injured condition and detained above noted 02 (two) accd. persons. During interrogation they confessed their guilt and stated that they along with 1. Raghav Tewari S/O Kumud Ranjan Tewari, 2. Gambhir Tewari S/O Lt. Nabakishor Tewari, 3. Krishna Tewari S/O Ramananda Tewari, 4. Mansaram Tewari S/O Dharanidhar Tewari, 5. Tarulata Tewari W/O Kumud Ranjan Tewari, 6. Shankaribala Tewari W/O Lt. Nabakishor Tewari, 7. Munmun Tewari W/O Aswani Tewari, 8. Sanat Tewari S/O Ramananda Tewari all of Vill-Meshya, PS-Jhalda, Dist-Purulia and 15/20 others of village Meshya under Jhalda PS and Chekya and Beladih villages under Kotshila PS under the leadership of Kumud Ranjan Tewari S/O Rash Bihari Tewari, Aswini Tewari S/O Lt. Nabakishor Tewari both of Vill-Meshya, PS-Jhalda, Dist-Purulia assaulted Police. So, I arrested above noted 02 (Two) accd. persons maintaining all formalities of arrest U/S 50 Cr.P.C and seized above noted articles from the PO and from the possession of arrested accd. persons. After recovery medical test of SI Hemanta Kr. Sahababu was done at Jhalda BPHC and he has been referred to Purulia Medical College and Hospital for better treatment.

Therefore I do hereby lodged this complaint against above noted accd. persons to start a specific case under proper section of law.
