Sir,

In producing here with two arrested accused persons namely Chandrabhanu@Gadhra Kumar (40+), S/O-Late Rohini Nandan Kumar & Janmenjoy@Joy Gope (25), S/O-Late Parikshit Gope both of Vill-Chekya, PS-Kotshila, Dist-Purulia (WB) and brought under seizure 01(One) seized Tractor having its Chassis No- MZJSH917220S3 & Engine No-3100FLU04B913294F18 (Model: Sonalika, D1-35, Blue colored) is attached with one sand loaded trolley and lodged this complaint to the effect that on 23.01.2021, I along with force C/2037- Pintu Bhuniya, C/888-Abinash Mandi and C/208-Chandan Dandapat were performing morning mobile duty at Tulin OP area as per order vide Tulin OP CC No-115/2021, Dt-23.01.2021 and at 10:05 hrs I/C Tulin OP received information that one tractor attached with sand loaded trolley hit on the boundary wall of Santosh Mahato, S/O-Lt. Baidyanath Mahato of Vill-Paprahurum, PS-Jhalda, Dist-Purulia (WB) which noted the fact in GD, reference Tulin OP GDE No-605, Date-23.01.2021. After that as per kind direction of I/C Tulin OP, myself along with force left to work out the said source information. Then we arrived at Paprahurum village on the spot and found one blue colored tractor (without number plate) attached with sand loaded trolley entered into house premise of Santosh Mahato, S/O-Lt. Baidyanath Mahato of Vill-Paprahurum, PS-Jhalda, Dist-Purulia (WB) by breaking his boundary wall. On conducting primary enquiry it came from villagers that the said incident has been happened due to rush and negligent driving of the driver of vehicle (Tractor) having its Chassis No-MZJSH917220S3 & Engine No-3100FLU04B913294F18 & the villagers detained driver & khalsi of the said vehicle (Tractor) after incident. On being interrogation driver of the vehicle namely Chandrabhanu@Gadhra Kumar(40+), S/O-Late Rohini Nandan & Khalasi of the said vehicle namely Janmenjoy@Joy Gope (25), S/O-Late Parikshit Gope both of Vill-Chekya, PS-Kotshila, Dist-Purulia (WB) could not produce any proper challan or any documents related to the said sand loaded Tractor. They confessed their guilty as well as confessed that they are with some peoples as well as owner of said tractor were dealing in sand business in clandestine manner and they do not have any proper challan or any documents related to the aforesaid sand loaded Tractor. So I arrested the above noted two persons namely Chandrabhanu@Gadhra Kumar(40+), S/O-Late Rohini Nandan (Driver of the vehicle) & Janmenjoy@Joy Gope, age-25Yrs approx. (Khalasi of the vehicle), S/O-Late Parikshit Gope both of Vill-Chekya, PS-Kotshila, Dist-Purulia (WB) after maintaining proper formalities also seized the above noted Tractor having its Chassis No- MZJSH917220S3 & Engine No-3100FLU04B913294F18 (Model: Sonalika D1-35, Blue colored) with attached sand loaded Trolley (approx 100 ctt)

On return to Jhalda P.S, kept the aforesaid sand loaded seized vehicle at PS compound and I do here by submitting written complaint before you to start a cog case against driver Chandrabhanu@Gadhra Kumar (40+), S/O-Late Rohini Nandan & Khalasi namely Janmenjoy@Joy Gope (25), S/O-Late Parikshit Gope both of Vill-Chekya, PS-Kotshila, Dist-Purulia (WB) and owner of the seized Tractor having its Chassis No- MZJSH917220S3 & Engine No-3100FLU04B913294F18 & others under proper section of law.
