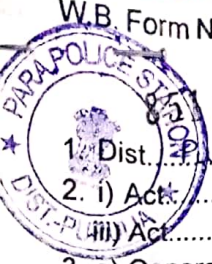



Sir,

In producing herewith arrested accused persons namely 1) Sagar Osta (27yrs) S/o Kismat Osta of Vill- Bamunbaid, 2) Mantaj Sha (33yrs) S/o Ayub Sha of Vill- Bamunbaid, 3) Bhutto Osta (32yrs) S/o Lt- Musuddin Osta of Vill- Bamunbaid and 4) Sk. Jahangir (28yrs) S/o Nur Islam of Vill- Hariharpur, all of PS Para, Dist- Purulia with seized articles viz. i) One improvised country made single shooter fire arms loaded with one round 0.8 m.m bore live cartridge having its butt, body, barrel, trigger etc. ii) Two Pcs. Iron rod of 2.5 ft (approx) each, ii) One knife of 07 inch (approx) made of steel with wooden butt, iii) One saw of 04 feet (approx), iv) One hammer with wooden butt of 01 feet (approx), v) One iron made Bhojali of 01 feet (approx), I SI Dipak Kr. Nandi of Para PS beg to inform you that today (28.01.2021) at 21.25 hrs. received a telephonic information from my trustworthy source that a gang of miscreants assembled a Palash Jungle near Rukni More to commit dacoity. Accordingly I noted it in GD vide Para PS GDE No- 1003 Dtd- 28.01.2021 and informed O/C Para PS. As per his direction myself along with PSI Kazi Kawsar Nafis, C/365 Chandi Charan Pandey, C/1137 Sridam Bauri, C/935 Sahadeb Majee, C/1034 Fakir Chandra Mahato and NVF/867 Sankar Chandra Dey left for working out the information after briefing my accompanying officer and forces about the gravity of information and my strategy to nab them (vide C.C. No- 160/21). We reached at Palash Jungle near Rukni More at 22.05 hrs. and keeping the vehicle parked there we moved to the spot on feet and found that 09/10 persons were gathered beside the Palash jungle in darkness. We encircled them but having the scent of Police they tried to run away but we managed to apprehend 04 (four) persons after a hot chase while the other fled away. On interrogation they revealed their identity as noted above. On searching One improvised country made single shooter fire arms loaded with one round 0.8 m.m bore live cartridge having its butt, body, barrel, trigger etc. was recovered from the possession of Sagar Osta, Two Pcs. Iron rod of 2.5 ft (approx) each were recovered from the possession of Bhutto Osta, one knife of 07 inch (approx) made of steel with wooden butt, One saw of 4 feet (approx) and One hammer with wooden butt of 01 feet (approx) were recovered from the possession of Sk. Jahangir and One iron made Bhojali of 01 feet (approx) was recovered from the possession of Mantaj Sha. Accordingly I seized the above noted articles from the possession in between 22:25 to 23:15 hrs. and interrogated them thoroughly and arrested them observing all the formalities regarding arrest. On interrogation they confessed that they assembled there to commit dacoity at Iron factory.


Hence I pray that a specific case may kindly be started against the above noted accused persons and 5/6 unknown persons under proper section of law and arrange for its investigation.
