Sir,

In producing herewith the arrested accd. person namely Baharul Islam (34 Yrs) S/o Jariful Islam of Vill- Dubra, PS- Para, Dist- Purulia I beg to submit that today (14.01.2021) at about 18.15 hrs. while I was present at P.S. SI Sukumar Hota, IC Anara OP came to PS with a CVF Bapi Chakraborty for PS work. After some time at about 18.25 hrs. the above noted person came to PS and started assaulting randomly the CVF Bapi Chakraborty in presence of me and some other Police personnel. Resulting the said CVF received injury on his person and shifted to Para BPHC where referred him to Raghunathpur S.S. Hospital and admitted there for better treatment. I detained the above noted person and by asking he revealed his name as Baharul Islam. I arrested that person and brought him in front of you. He deterred an on duty CVF at PS premises from discharging Govt. duty and also voluntarily caused grievous hurt to him on his duty.

Under the above fact and circumstance I therefore pray that a case u/s 353/186/333/307 IPC may kindly be started against Baharul Islam (34 Yrs) S/o Jariful Islam of Vill- Dubra, PS- Para, Dist- Purulia and arrange for its investigation.
