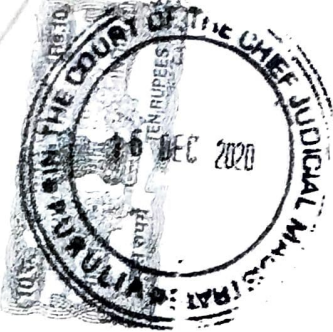

Most respectfully begs to state:

1. That the Complainant, Accused Persons and the Witnesses No.3 to rest are the permanent resident of several Villages including Kalidasdih, Bamro, Shyampur, etc. within P.S.-Purulia(M), District:- Purulia, having their residential houses therein.
2. That the Complainant owned one Mahindra Bolero Vehicle being No.WB-55A/1600, being the registered owner.
3. That the Accused No.1 is the maternal uncle of the Complainant & he for his personal requirement took the said Bolero vehicle from the Complainant 3/4 days prior to 13/11/2020.
4. That on 13/11/2020 at about 03 P.M. the Complainant went to village Bamro for bringing the said Bolero from the Accused No.1.
5. That when the Complainant reached at Village Bamro he asked for the Accused No.1, but he came to learn that the Accused No.1 was at his Brick Bat. At that time the Complainant could not find his Bolero Vehicle at the house of the Accused No.1.
6. That on arrival at the Brick Bat of the Accused No.1, the Complainant requested the Accused No.1 to hand over the key of the Bolero Vehicle. But all on sudden without any reason the Accused No.1 directed the other Accused Persons to assault the Complainant & accordingly the Accused Persons started assaulting the Complainant.
7. That at that time Accused No.2 tried to assault the Complainant with spade (Kodal) on his head, but somehow he escaped & he sustained injuries on his heap-joint, & the other Accused Persons with feast, blows assaulted him.
8. That on the midst of such assault the Complainant somehow escaped therefrom otherwise he would be killed.
9. That for such injuries the Complainant admitted at Deben Mahato Sadar Hospital, Purulia, where the M.O. treated him & ultimately discharged him on 15/11/2020.
10. That on arrival to his house, the Complainant came to learn that the Accused Persons along with 30/40 persons illegally trespassed into the house of the Complainant & threaten his old mother i.e. witness No.2 with dire consequences. They also threatened the witness No.2 that if the Complainant again went to bring back his Bolero Vehicle he will face dire consequences. The Complainant apprehends that the Accused No.1 has already misappropriated the Bolero vehicle bearing registration No.WB-55A/1600.
11. That at that time hearing hue & cry of the Witness No.2, some local persons reached there & on seeing them the Accused Persons left the place.
12. That the Complainant thereafter on several occasions informed the 1/C Purulia(M) P.S. about the matter in writing but the 1/C Purulia(M) P.S. did not take any action in the matter up-till now.

13. That the Complainant also informed the matter to the S.P. Purulia on 17/11/2020 but up-till now no action has been taken by the police. In the meantime the Accused persons are regularly threatening the Complainant with dire consequences.

14. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the I/C Purulia(M) P.S. for investigation & further be pleased to pass necessary order.
