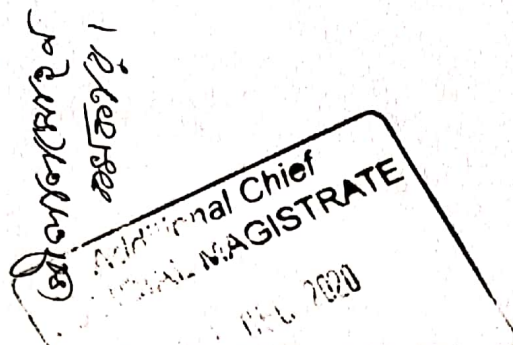

That the complainant most respectfully beg to state as follows:-

1. that the complainant is the resident of village- Puapur, P.O.- Chalmara, P.S.- Neturia, Dist.- Purulia, W.B. and the incident took place within the jurisdiction of your Id. Court.
2. that the complainant is the elder brother of SABITRI KARMAKAR D/O. Lt. GURUPADA KARMAKAR, who got married with SHYAMAPADA KARMAKAR S/O. Lt. PUCHIRAM KARMAKAR, on 22/06/2001, and blessed with three children.
3. That on 15/06/2020, the mother of the complainant namely MADHURI KARMAKAR, get information from the husband of SABITRI KARMAKAR, that SABITRI KARMAKAR, was missing from 15/06/2020, and on being asked by said SHYAMAPADA KARMAKAR, the mother of the complainant went to Raghunathpur Police Station on 27/06/2020 and lodged the Missing

Diary as per instruction of said SHYAMAPADA KARMAKAR, vide Raghunathpur G.D.E. no.- 1233 dated 27/06/2020.

4. That later on the complainant came to learn from the local people of village CharanBandh under Raghunathpur Police Station, that his sister was subjected to physical assault, on and often by her husband namely SHYAMAPADA KARMAKAR, and other inlaws namely Smtya. PRUNIMA KARMAKAR(mother in law), BAMAPADA KARMAKAR and RAMAPADA KARMAKAR (brother in law) and threaten her to kill.
5. That since the alleged date of missing 15/06/2020 of the sister of the complainant, neither her husband nor any inlaws had taken any sincere efforts for the searching of his sister or lodged any missing diary before the local police station, rather used the illiterate mother of the complainant to lodge missing diary after lapse of 12 days to save their skin from wrong done by them.
6. That there is every reason, chance and possibility, that SHYAMAPADA KARMAKAR, Smtya. PRUNIMA KARMAKAR(mother in law), BAMAPADA KARMAKAR and RAMAPADA KARMAKAR (brother in law) all are of village Charanbandh, P.O.- Nildih, P.S.- Raghunathpur, Dist.- Purulia, W.B., killed the sister of the complainant and caused disappearance of her dead body.
7. That on 04/07/2020, the complainant went to Raghunathpur Police Station to lodge the written complaint dated 04/07/2020, but the police of Raghunathpur Police Station refused to receive the same.
8. That due to Covid-19, the complainant could not been able to make the application to S.P. office, Purulia thus on 03/10/2020, the complainant made a application to S.P. Purulia, about the incident noted above vide registered letter dated 29/09/2020, but till today there is no any fruitful result.
9. That finding no other alternative, the complainant have to take shelter before the Id. Court for the redressal of his grievance.

It is therefore prayed before the Id. Court may kindly allow this petition treating the same U/S 156(3) of Cr.P.C. , and to pass necessary order/orders , direction/directions, to the Inspector In Charge, Raghunathpur Police Station to treat the same as F.I.R. against the above named accused persons and any other order/orders, direction/directions , as your Id. Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
