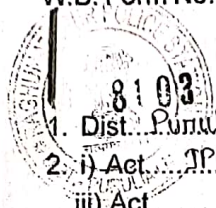

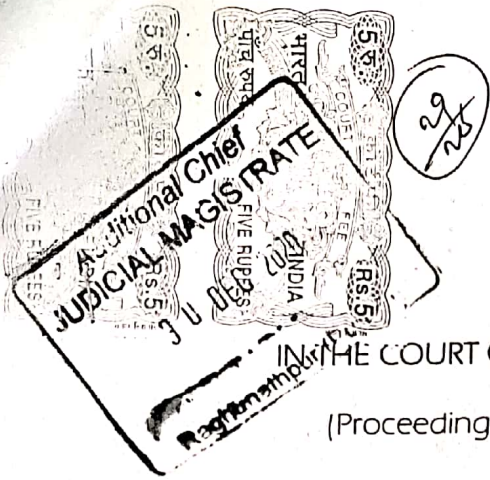

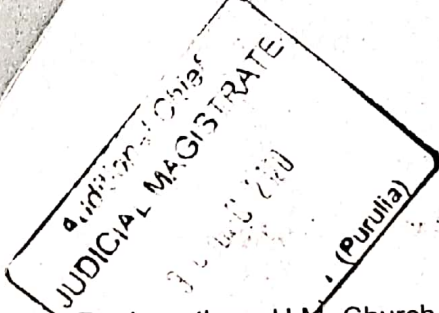

**That the complainant most respectfully beg to state as follows:-**

- 1. that the complainant is at present the Secretary of Raghunathpur U.M. Church which is situated under Raghunathpur Police station within the jurisdiction of your Id. Court, whereas the accused no.1 is the Ex- Chairman and accused no. 2, is the Ex-Chairman of Raghunathpur U.M. Church, Raghunathpur.
- 2. That after being appointed as Secretary on 08/12/2019, the present complainant came to know that the entire donation which was duly received by the

- Raghunathpur U.M. Church from its devotee, has not been properly recorded by the above named person and some money has been kept by the accused and less amount of money out of donation has been deposited in the UBI Bank now PNB Bank account belong to the Raghunathpur Church Society under Raghunathpur Church, as they have been seated in the official capacity of Chairman and Treasurer on and from 12/09/2020.
3. That a letter/notice dated 20/01/2020, by the Raghunathpur Church Committee has been made to the accused no. 2, with request to deposit the Bank Account Book along with Ledger book and connected paper relating to the donation and other gifts by the devotee to the Raghunathpur U.M. Church on 09/02/2020, but he failed to comply the direction of the notice till today.
  4. That the matter has been informed to Rev. Joren Basumata, Chairman, UMS Kolkata, where the Hon'ble Chairman directed the accused no. 1 and 2 to submit the UBI Bank now PNB Bank Account Book vide A/C. no.- 0199010031283, with other connected paper to the present committee, but both the accused person has not hand over the above noted documents to the present committee till today.
  5. That it is believed by the Raghunathpur Church Committee, that said accused no. 1 JOHN HEMBRAM & accused no. 2 AMOSH PRASAD, from very inception of taking advantages of being in their official capacity, dishonestly misappropriate the fund of Raghunathpur Church Committee amounting Rs. 22,00000/- (twenty-two lakhs only) during the period of holding of the respective chair, and committed the criminal breach of trust by causing fraud.
  6. That the defecto complainant went to Raghunathpur Police Station on 24/09/2020, and submitted the application, but when finding no result, made a registered letter to the S.P. Purulia as well as Inspector In Charge, of Raghunathpur vide dated 18/11/2020, but the concern authority till today has not consider the application of the defecto complainant till today.
  7. that finding no other alternative, the complainant have to take shelter before the Id. Court for the redressal of his grievance.

It is therefore prayed before the Id. Court may kindly allow this petition treating the same U/S 156(3) of Cr.P.C. , and to pass necessary order/orders , direction/directions, to the Inspector In Charge of Raghunathpur Police Station to treat the same as F.I.R. against the above named accused person and any other order/orders, direction/directions , as your Id. Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
