Sir.

In producing herewith one arrested accused person namely Aman Kumar Upadhyay @ Man (32 yrs.) S/O Lt. Jagannath Upadhyay of Palashkola Tiger Colony, PS-Adra, Dist- Purulia (1) one improvised pipe gun (Country made) having butt body barrel, trigger length approx 20. 3 c.m (2) One 8 mm like live cartridge which was loaded inst-1 and seized after un loading seized by under proper seizure list.

I SI Joydeb Mondal presently posted at Adra PS, do here by lodge complaint that on 07.02.2021 at about 19:45 hrs I/C, Adra PS received a source information that one person aged about 32/35 yrs was moving near Monpura rail gate Jungle side, keeping possession of arms and ammunitions with a motive to commit any cognizable offence at the point of fire arms, the information was diarized in General Diary by I/C, Adra PS vide Adra PS GDE No 279 Dtd. 07/02/21 and he directed to work out the information to me while I was engage in evening Mobile duty vide Adra PS C.C No- 407/21 dtd.07/02/21. As per order of I/C Adra PS I along with C/-312 Radheshyam Mondal, HG/1682 Amal Baran Majhi had been to "Monpura rail gate Jungle side" at about 20:15 hrs. and watched the person from a distance after concealing himself behind a closed bush. I along with force found that a person was moving suspiciously along the road and as the road was lonely at that time so, he was waiting by the side of a bush (at a distance of about 50 mtrs. from the Monpura rail gate Jungle side) in order to commit any crime upon any pedestrian/motorcyclist etc. At the sight of Police the said person took to his heels and after a chase he was caught hold. On interrogation he disclosed his name as stated above. I asked for his presence in such a lonely place at above noted place and he made different statements at different times. Then I offered the said Aman Kumar Upadhyay @ Man to search me and my Police party before searching his body, but he refused. Then I searched his body and found one country made single shooter improvised pipe gun which was loaded with one 7.5 mm like live cartridge ammunition at his waist. I demanded for relevant license/document from him in respect of possessing the said fire arms and ammunition, but he failed to produce any such valid documents in respect of possessing the said fire arms and ammunition and could not give any satisfactory account in this regard which made him to believe that the accused person possessed those fire arms and ammunition illegally for some ulterior motive. So I seized (1) one improvised pipe gun (Country made) having butt body barrel, trigger length approx 20. 3 c.m (2) One 8 mm like live cartridge which was loaded inst-1 and seized after un loading from the exclusive possession of accused Aman Kumar Upadhyay @ Man under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized item. Then I arrested the above noted accused person after issuing Memo of Arrest & Inspection Memo and after obtaining all formalities and guidelines as laid by the Apex Court of India, NHRC and WBHRC as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. I tried to collect public witnesses but as it was night time and the place was lonely, I could not arrange for any public witnesses. Accordingly after returning at PS, I produced the arrested accused along with the seized fire arms and live ammunition with all relevant documents.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Aman Kumar Upadhyay @ Man (32 yrs.) S/O Lt. Jagannath Upadhyay of Palashkola Tiger Colony, PS-Adra, Dist-Purulia and to arrange for its investigation.
