Sir,

In producing here with the arrested accused persons namely (1) Lilangshu Das (26 Yrs) S/O Montu Das Vill- Parasole, PS-Kashipur, Dist- Purulia and (2) Koushal Ghatowal @ Rajkumar (28 Yrs) S/O Chander Ghatowal A/P Vill- Ranguni Kolpara, PS-Adra, Dist- Purulia, as disclosed by the arrested accused persons along with seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A'-One white colored printed green and red nylon bag (ii) Exhibit Mark-'B'- One green colour plastic bottle along with green colored cap containing 2106 gram (including bottle) i.e. approx 2.314 Ltr. of light red colored codeine mixture (rest mother sample after taken out Exhibit Mark "B1" & "B2"), (iii) Exhibit mark - 'B1" 100 ml. of codeine as test sample taken from Exhibit Mark "B". (iv) Exhibit mark "B2" 100 ml. of codeine as security sample taken from Exhibit Mark "B". (V) Exhibit Mark-'C'- One green colour plastic bottle along with green colored cap containing 2106 gram (including bottle) i.e. approx 2.314 Ltr. of light red colored codeine mixture (rest mother sample after taken out Exhibit Mark "C1" & "C2"), (vi) Exhibit mark - 'C1" 100 ml. of codeine as test sample taken from Exhibit Mark "C1". (vii) Exhibit mark "C2" 100 ml. of codeine as security sample taken from Exhibit Mark "C2". (viii) Exhibit mark "D" One black colour Passion Pro having Reg. No-JH15G/2966, Chassis No-MDCHA10AWCHG03250, Engine No-HA10ENCHG02378 Exhibit mark B1 & B2 were collected from Exhibit "B" which was 2306 grams (including Bottle) of light red colored codeine mixture and Exhibit mark C1 & C2 were collected from Exhibit "C" which was 2306 grams (including Bottle) of light red colored codeine mixture. All Exhibits are in properly sealed and labeled condition under proper seizure list.

I, SI Sourav Banerjee of Adra PS do here by lodge this complaint as suo-moto to the effect that today (15/02/2021) at 22:15 hrs received a secret information from my source that 02 (two) persons would be coming from Kashipur side and may proceed towards Adra side through Adra - Kashipur Pitch road with some contraband goods suspected to be narcotic substance in order to sell the same. On received such information I immediately diarized the fact in GD vide Adra PS GDE No 608 dated- 15.02.2021 and informed the matter to IC Adra PS who please directed me to proceed to work out the information. As such as per his direction I SI Sourav Banerjee along with (i) ASI- Rajkumar Goswami (ii) C/1434 Jagannath Mondal (iii) C/174 Tapan Das Bauri (iv) PD/896 Sahadeb Orang, all are Adra P.S. left at 22:35 hrs for Roguri More i.e. Adra Kashipur Pithch Road, after preparing inventory list, by Govt. Vehicle No WB WB55/3700 attached to Adra PS equipped with govt. supplied arms and ammunition, weighing machine, investigation kit box, white paper, gala, white cloth, carbon paper, stamp pad, seal of Adra PS, envelope etc. vide Adra PS CC No. 503/21Dt. 15.02.2021 & Adra PS GDE No-614 dt. 15.02.2021.

At about 22:55 hrs reached near to Roguri More i.e. Adra Kashipur pitch road under Adra PS. After reaching, the said Govt. vehicle was kept in reasonable distance conducted ambushed up to 00:05 hrs on 16.02.2021. At that time found 02 (two) persons approaching towards Adra side by one black colour Passion Pro Motorcycle having Reg. No-JH15G/2966 from Kashipur side with a bag. While they reached closer to police party we surrounded them and focused our torch light and detained them. On asked they disclosed their identity as (1) Lilangshu Das (26 Yrs) S/O Montu Das Vill- Parasole, PS-Kashipur, Dist- Purulia and (2) Koushal Ghatowal @ Rajkumar (28 Yrs) S/O Chander Ghatowal A/P Vill- Ranguni Kolpara, PS-Adra, Dist- Purulia. We informed them that we have specific information that they have illegal narcotic substance and they admitted that they procured and carrying codeine mixture without any valid papers and others.

In the meantime one Bikram Pratap Singh S/o Lt. S.M Singh of Lower Jhariadih Adra, and 2) Shib Kumar Shaw S/o Lt. Ram Piyari Shaw of Kamlasthan Adra both of PS – Adra, Dist.- Purulia who were returning to their home via Adra Kashipur pitch road on bike and reached at Roguri More, Adra. I requested them to wait for some while as disinterested witnesses, as because we will be ready to search the above noted two detained persons in presence of them.

I also issued notice as per NDPS Act to the detained persons in order to conduct their search by a Executive Magistrate or by any Gazetted Police Officer. They informed in writing that they have no objection if the search conducted either by any Gazatted Police Officer or by any Executive Magistrate. Accordingly I informed IC Adra PS- Insp. Samir Ranjan Lala at about 00:15 hrs on 16.02.2021 regarding the whole things. I also contacted BDO Kashipur but he is not available due to engage in upcoming Assembly Election.

At 00:25 hrs, IC Adra PS also informed me over telephone that no Executive Magistrate could be made available as such odd hours of the night. As such as per request of the above noted 02 (two) detained persons IC Adra PS proceeding to the spot.

At about 00:45 hrs Insp Samir Ranjan Lala, IC Adra PS reached there and I narrated him about the development. He disclosed his identity before the detained persons and asked me to issue notice to the detained persons, offering them to search the available police personnel present there as well as the public witness present there, but they showed no interest and refused to conduct any search of the police personal and public witness in writing.

As per direction of IC Adra PS, I conducted search of (1) Lilangshu Das (26 Yrs) S/O Montu Das Vill- Parasole, PS-Kashipur, Dist- Purulia and (2) Koushal Ghatowal @ Rajkumar (28 Yrs) S/O Chander Ghatowal A/P Vill- Ranguni Kolpara, PS-Adra, Dist- Purulia, in between 00:55 hrs to 01:45 hrs.

During search I recovered one white colour nylon bag in which found Two Green colour plastic Bottle along with Green colored cap containing light red colored liquid. On interrogation they admitted that it is the codeine mixture and they are habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for their wrongful gain, knowing the same is a punishable offence. On demand they failed to produce any documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of IC Adra P.S I weight the 02 Bottles and it resulted total in 4612 grams including Bottles in weighting machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be codeine mixture from which 100 ml each were taken in 04 (Four) plastic bottles as test samples and security samples from two mother samples. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused persons. I also supplied a copy of seizure list to the accused persons. I arrested the detained persons maintaining all formalities. The seized bottles were properly labeled and sealed.

In between 02:05 hrs to 02:25 hrs I prepared another inventory list containing weighting machine, investigation tool kit, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle, two empty small bottles, the two bottles i.e. mother samples consists of 2106 gram each and other four bottles contains 100 ml each of seized codeine mixture) and two small bottles in presence of witnesses and accused persons. The entire process was supervised and directed by IC Adra PS, Sri Samir Ranjan Lala.

On 16/02/2021 after returning to the PS seized Alamats and samples were deposited to the Malkhana dealing Officer and kept at PS Malkhana.

At PS the accused person further searched by Police personnel and put him into the PS lock up after observing all Hazat rules and informed on duty table Officer and caution the sentry duty.

That, I the complainant drafted and prepared the complaint by typing on going through the records of the Case. The relative of the arrested accused person is being informed.

The accused persons are liable for prosecution U/S- 21(c) /29 of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against (1) Lilangshu Das (26 Yrs) S/O Montu Das Vill- Parasole, PS-Kashipur, Dist- Purulia and (2) Koushal Ghatowal @ Rajkumar (28 Yrs) S/O Chander Ghatowal A/P Vill- Ranguni Kolpara, PS-Adra, Dist- Purulia, U/S- 21 (c) /29 of NDPS Act 1985 as amended up to date and arrange for its investigation.
