In producing herewith the arrested person namely Chhote Momin @ Sabu Momin (37 Yrs), S/O-Jamiruddin Momin of Vill-Jilling, PS-Baghmundi, Dist-Purulia, A/P Vill-Choura, PS-Tiruldih, Dist-Saraikela Kharswan, (JKD) along with the seized article i.e, 1) One country made iron one shooter gun (improvise) having length 25 cm (Approx) loaded with one live cartridge. I beg to state that today i.e 15.02.2021 at 20:45 hrs received an information from a credible source that two unknown suspected persons with ill intension were standing with motor cycle near Kantadih River on Patahansal to Kantadih Moram Road then I along with force (vide Suisa OP GDE No-393, Dtd: 15.02.2021 and C.C No-215, Dtd: 15.02.2021) left for working out the matter and when I reached near Kantadih river and found that one person sitting on a bike and another person standing beside him.
