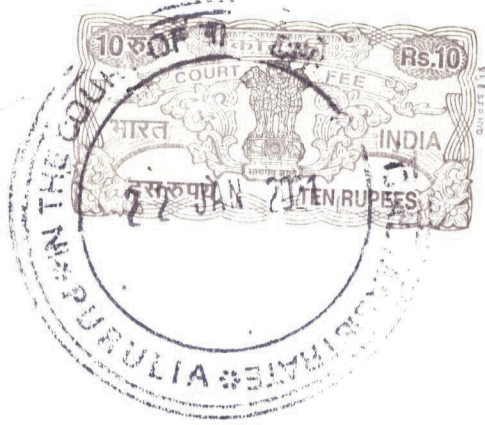

The Complainant above-named;

Most respectfully sheweth:-

1.---That the Complainant is the wife of the accused No. 1 and their marriage was solemnized on 26-06-2019 in Muslim Law according to their customary rites and formalities in their community and their marriage tie is still subsisting and at the time of marriage father of the complainant gave a sum of Rs.1,20,000/- (Rupees One Lakh Twenty thousand) only in cash and 5 (five) Bhories of Gold ornaments, 25 bhories Silver ornaments and other utencil and bedding. The Den Mohar have been fixed i.e. Rs.31,000/- (Rupees Thirty one thousand) only.

2.---That after marriage the complainant went to the house of accused No.1 Jhariadih Lower Basti, Adra and began to live there with her husband (accused No.1) and other family members of her husband in joint family.

Accused No.2 to 4 are the brother -in-law of the complainant and the accused No.5 and 6 are the sister-in-law of the complainant.

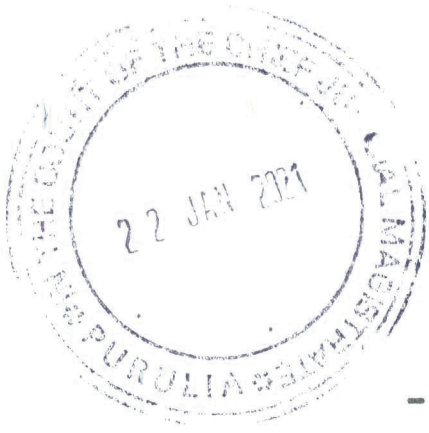

3.---That from the very beginning of the starting of conjugal life, the accused persons were not happy with the dowries which were brought by the complainant to the matrimonial home and over that issue all the accused persons used to taunt her and also used to throw abusive and objectionable languages aiming at the parents of the complainant.

4.---That however the complainant were bearing all such torture on the expectation that there would develop good sense in the mind of the accused persons but such illtreatment and torture started aggravated day to day and that in the process the accused persons used to deprive the complainant with the daily necessities and also they used to assault her off and on.

5.---That after two months since marriage the accused persons put pressure upon the complainant to bring a Motor cycle from her father which was due at the time of marriage as per demand. And the complainant intimated the said fact of demand to her father, then the father of the complainant expressed that he already gave all as per their demand and at present he has no any inability to meet any further demand.

6.---That when the said demand not meet from the side of the father of complainant the accused persons became

furious and started her abusing and also deprived her all daily necessities like not to give proper food, medicine, not to allow her in bed and also assault without any reason. Such cruelty and harassment continued day to day some time by jointly and some times by Accused No.1 and make the life of the complt is horriable and restless and one night with the consult^d of the accused No.1, accused No.2 (Chand Hack) was trying to kill the complainant by one knief and any how your complainant saved but as a result her right hand is totally useless and on the said hand she is unable to do any work.

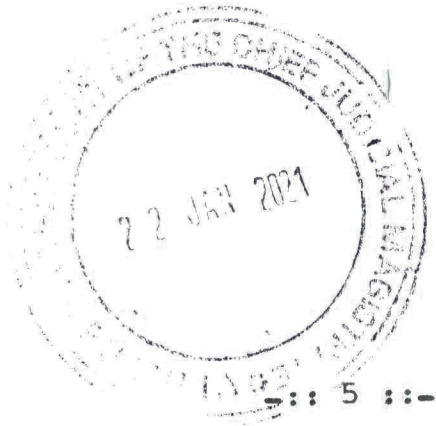
7.---That on 04-02-2020 the accused persons drove out the complainant after assaulting her mercilessly from their house after snatching all the ornaments. The complainant any how came to her father's house at Balarampur and stated all the facts to her relatives and since then she is living in her father's house at Balarampur.

8.---That on 25-09-2020 the accused No.1 and 2 all on a sudden came to the father's house of the complainant at

Balarampur and there after in night after consultation ² amicably

and on the following date when all the family members were busy in their business. Then the accused No.1 and 2 assaulted the complainant by belt and accused No.2

assaulted the complainant on her head by Hurka(Lathi) and also threatened that they will not allow her till not to meet the demand and they left the place by their Motor cycle, due to assault and heavy pain the complainant went to Balarampur Hospital for treatment and till the treatment is continued.

9.---That there after on several occasions the relatives of the complainant tried to their level best to understand the accused persons but they did not pay any heed not only that they also abused then in filthy languages.

10.---That the complainant lodged a Written complain before the O/C Balarampur P.S. against the accused persons but police personel of Balarampur P.S. not to take any step against them, then the complainant lodged a complaint before S.P. Purulia but off no good.

11.---That accused persons have committed several criminal offences. The complainant is one poor lady, she is totally depends upon her father and could not effered the expenses of the case forwhich the complainant seek justice.
