



The above name complainant begs to state as follows:

possessor of a piece of land which is situate at mouza Supudhi, under P.S. Bandwam, Dist- Purulia, recorded as J.L. No. 19, Khatian no. 518, Plot no. 517, 518 and 520, total area 173 decimal is owned and possessed by me and the complainant has got the same through inheritance and previously the father (since deceased) of the complainant possessed the same in various ways.







The above noted persons have no concerned over those plots nor the accused persons have any manner of possession over the same. And that the aforesaid plot have duly been recorded in the name of the father of the complainant. In such circumstances the complainant learnt from a very reliable source that those plots have recorded in the name of said Madhab Mahato without any reason.

Hearing such the complainant though the right and act filed one application before the B.L. & L.R.O. Bandwan requesting him to state the reason as to why those plots were recorded in the name of said Madhab Mahato, in his reply the complainant came to know that the above mentioned Pradhan, Member, with the connivance of others miscreants named of whom have been given hereinabove and the certificate issued by said Pradhan in favour of said Madhab Mahato, wherein father's name of Jugal Mahato is written as Mangal Mahato. But actually father's name of Jugal Mahato is Gokul Mahato.







But all the above mentioned persons in connivance of each other the Pradhan of Supudih Gram Panchayat one certificate like document when father's name of Jugal has been shown as written as Mangal Mahato. Thereafter, the above noted Panru Mahato executed and registered a fake and inadmissible deed as Panru Mahato has no right over the property covered in the said deed in favour of said Baisakhi Mahato (Since deceased) wife of Gunadhar Mahato and Baisakhi is the mother of above noted Gunadhar Mahato. So, it was well proved that the above noted persons including Pradhan, member of Supudih Gram Panchayat and the witness of the documents named above in connivance with each other along with Madhab Mahato and his deceased mother Baisakhi for their personal gain and loss to the complainant has intentionally somehow managed to get registered the said deed which the complainant has learnt about the said deed form the office of B.L. & L.R.O. Bandwan and the deed itself is proved to be false, not acted upon and accordingly it has got no value in the eye of law and accordingly all of them have actually fraudulently and








dishonestly got the deed registered though Panru Mahasto, but Panru Mahato has no right to execute the deed in favour of any one including the said Baisakhi Mahato.

Thereafter, all the above mentioned miscreants by influencing the B.L. & L.R.O. Bandwan of their power have prepared to record in favour of Madhab Mahato. For which the complainant became cheated by them in the manner stated herein above which also caused damaged and harm to the body, mind and reputation etc of the complainant.

- 2) That the accused persons have committed various offences punishable under the Indian penal code including section for which they are deserved to be punished under the law.
- Bandwan P.S. against the accused persons, but said Officer-in-charge did not taken any legal action against the accused persons, then the complainant lodged another complaint to the Superintendent of Police, Purulia, but with same fate, then the complainant is under compelling circumstances is







filing this complaint before the Ld. Court for appropriate reliefs under the law.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Bandwan P.S. for treating the same as FIR under section 156(3) for investigation.
