

Fact of the case in Brief:-

1. That the complainant is the rightful owner of the Bahal land measuring 20 decimals which he has purchased from Sripati Mudio vide Registered sale deed no 9362 for the year 1969 and since his purchase he is in cultivating possession over the same and like other years this year also the complainant grown paddy crops by expending his labour and money and the paddy crops were ready for hervesting, but the accused persons on 11/11/2020 at about 10 A.M. forming un-lawful assembly trespassed into the land of the complainant and forcefully cut and removed the paddy crops of the complainant standing over the said R.S. Plot no 648 inspite of the objection of the complainant, there by the accused persons committed theft and put the complainant in criminal loss of 8 monds of paddy and the straws which amounts to Rs 12000/- in money value.

2. That the complainant had to inform the incident to the P.S. Barabazar on the same day and by Registered post on 13/11/20 and to the S.P. Purulia on 17/11/2020 but no action has yed been taken against the accused persons, hence the complainant has been compelled to file this petition, the accused persons are moving freely in the area and are threatening the complainant regularly.
