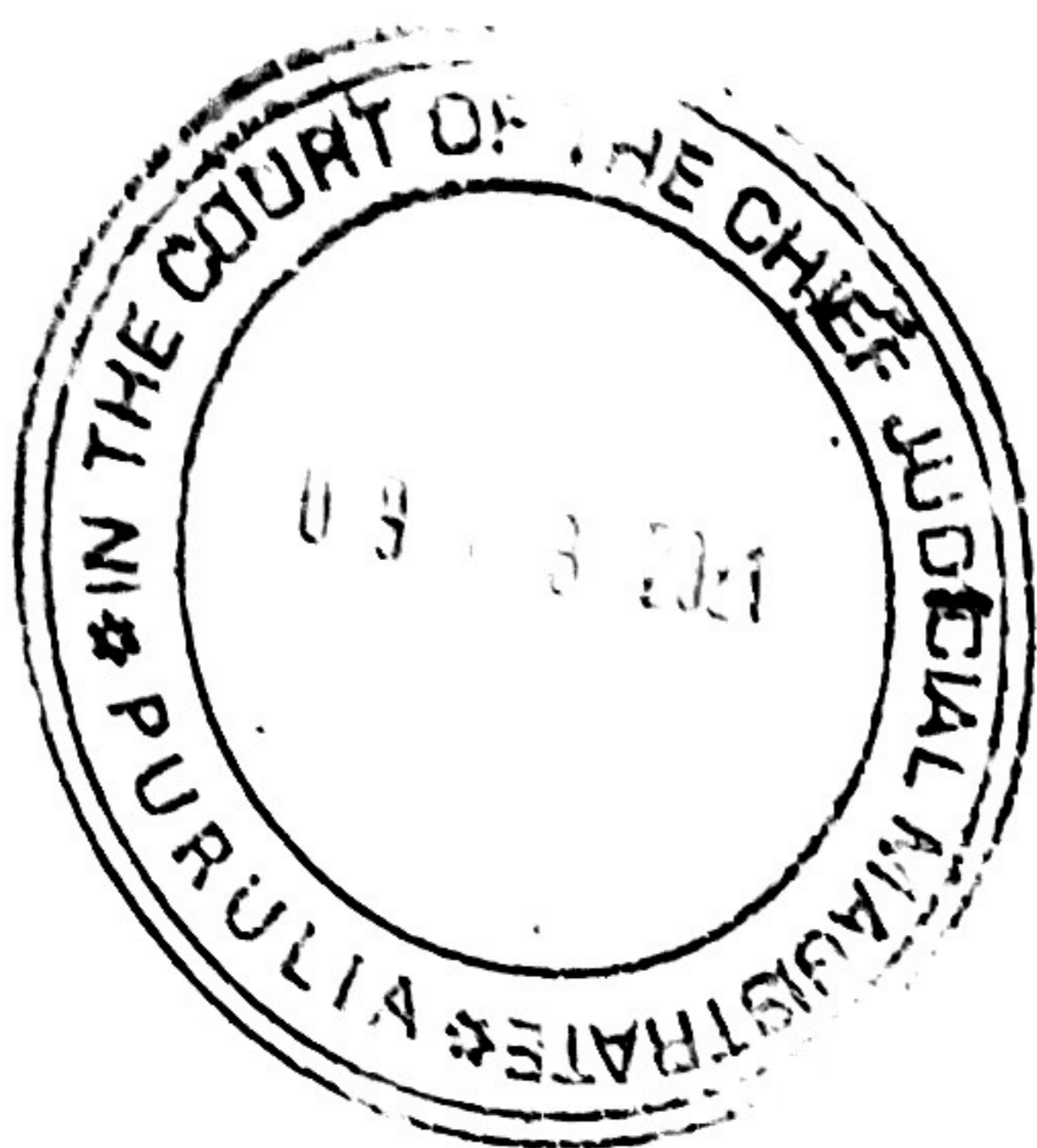

At the house of the accd. persons at village & P.O. – Bhikhari Chellayama, P. S. – Barabazar, District – Purulia and her matrimonial home at village Jordiha, P.S. Kharswana, District Saraikela Kharswana.

The above name complainant begs to state as follows:-

1. That your complainant is the resident of village & P.O. Bhikhari Chelleyama, P.S.- Barabazar, Dist.- Purulia and the place of occurrence is under P. S. Barabazar, District Purulia and within the jurisdiction of this Ld. Court.
2. That your complainant was married with one Bideshi Mahato, S/O Biswanath Mahato, resident of Village Jordiha, P.O. – Barabambo, P.S. - Kharswana, District Saraikela Kharswana on dated 22.11.2019 corresponding to 05th day of Agrahayan 1426 B.S. as per Hindu rites and customs prevalent in their society.
3. That after solemnization of marriage the accd No 1 took your petitioner to his residential house at village Jordiha, P.O. Barabambo, P.S. Kharswana, District Saraikela Kharswana (Jharkhand) and started living there as husband and wife and marriage was duly consummated. And after expiry of one month of peace ful matrimonial life the accd. No 1 and his family members demanding further dowry of Rs 2,00,000/- (Rupees Two lakhs) from your complainant with an excuse to set up a business.
4. That the father of your petitioner is a poor farmer and at the time of marriage a sum of Rs 80,000/- (Rupees eighty thousand), one Motor Cycle (Hero Honda C.D. Delux), gold ornaments weight 3 Bhories, Silver ornaments weight 6 Bhories, utensils and furniture's all total of



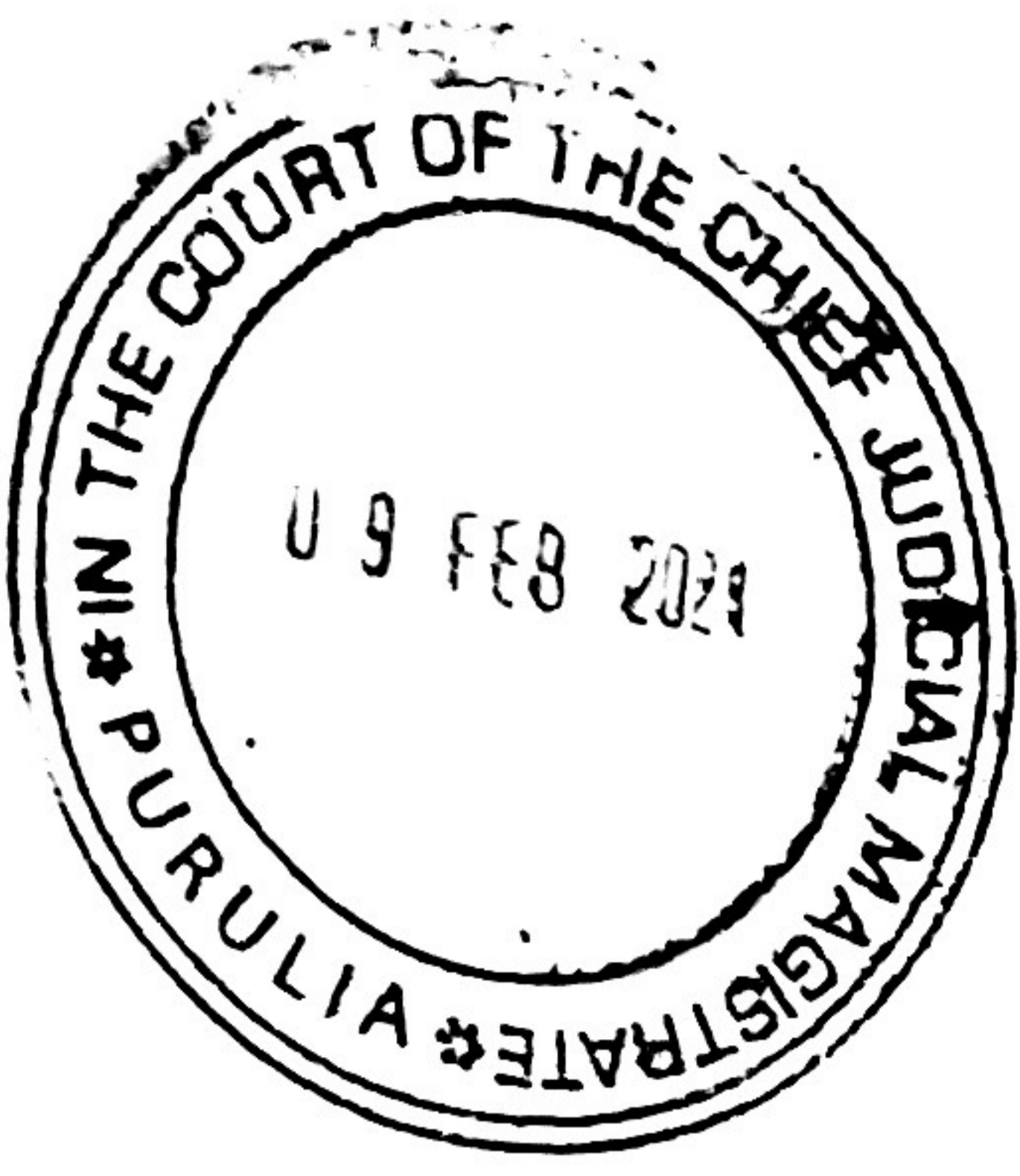

Rs. 6,00,000/- (Rupees six Lakhs) which includes cash provided to the accd no 1 as per their demand.

- 5) That the loan amount of which is yet to pay so your petitioners father was incapable to provide any further dowry. At this the accd. persons become furious and intensified the quantum of torture day by day and the torture reached its extreme when on date 07.01.2021 (Corresponding to 27th day of Pous 1427 B.S.) in a pre plain way when all the accd persons tried to snatched the life of your complainant by way pouring Kerosene over the body of your complainant escaped to her father ' s house at village Bhikhari Chelleyama, and took shelter there. And thereafter in 12.01.2021 at morning all the accd. persons came to the father's house of your complainant at village Bhikhari Chelleyama, P.S. Barabazar, District Purulia and assaulted your complainant and her family members with fist and blows. At this your complainant raised hue and cry and hearing the noise the villagers came and the accd. persons fled away.
- 6) That thereafter your complainant reported the matter to the local P.S. at Barabazar and Supertendant of Police Purulia but till today not any action has been taken by the police against the accd. persons. So your complainant takes shelter before your Honours Court.
- 7) That the accd. person have committed the offence and they are liable to be punished accordingly.
