In producing here with three arrested accused persons namely (i) Sk. Tabaruk (24 Yrs) (ii) Sk. Mahfuz @ Mufuj Alam (22 Yrs) both S/O Sk. Manir @ Maniruda.; of Vill- Hossendih A/P Bagandih, PS-Jhalda, Dist- Purulia (iii) Sandip @ Pelu Kumar (21 Yrs) S/O Lankeswar Kumar of Vill- Chekya, PS-Kotshila, Dist- Purulia and brought under seized articles i.e. (i) 216 (Twenty hundred sixteen) Pcs sealed bottles of OWNREX Cough Syrup @ 137 Rs./bottle, having 100 ml in each bottle (ii) One Tempo having Reg. No- JH10BX 9001.

I do here by lodged a written complaint against the above noted accused persons to the effect that on 03/02/21 at 18:15 hrs while performing Anti Crime evening mobile duty myself ASI- Samir Kumar Mishar along with force (C/538- Dayamay Mahato, C/1496- Subal Chandra Mahato, C/2983-Biplab Singha Mahapatra and H.G/1681- Manamatha Kumar with Govt. vehicle, vide CC No-317/21, Dtd. 03/02/21 and started Anti Crime Naka checking at Kanshra more on Jhalda-Gola Road. At 18:35 hrs. we detained on Tempo having Reg. No- JH10BX 9001 and found 03 persons inside the Tempo. On suspicious ground we checked and searched the Tempo and found they were carrying 02 cartons containing 216 (Twenty hundred sixteen) Pcs sealed bottles of OWNREX Cough Syrup @ 137 Rs./bottle, having 100 ml in each bottle. On demand they failed to produce any valid documents/ license in respect of keeping the said drugs. On being asked they disclosed their identity as noted above and admitted that they along with Barun Kuiry of Vill- Mohanpur, PS- Kotshila, Dist- Purulia and 02/03 others are dealing with this illegal business of Corox and they purchased those from Jharkhand and used to sell to the local people of Jhalda and Kotshila.

So I seized the same from their possession and involved vehicle Tempo having Reg. No- JH10BX 9001 under proper seizure list duly signed by the Police witnesses as there was no other local witness available right that moment and as well signed by the apprehended persons and also prepared label with seal one bottle of "OWNREX Cough Syrup" as sample. I arrested the three accused persons for violating the sec. 27 of drugs & cosmetics Act 1940 after maintaining all formalities and also inform them the ground of arrest.

I therefore pray before you to start a case against the above noted arrested three accused persons namely (i) Sk. Tabaruk (24 Yrs) (ii) Sk. Mahfuz @ Mufuj Alam (22 Yrs) both S/O Sk. Manir @ Maniruddin of Vill- Hossendih A/P Bagandih, PS- Jhalda, Dist- Purulia (iii) Sandip @ Pelu Kumar (21 Yrs) S/O Lankeswar Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia (iv) Barun Kuiry of Vill-Mohanpur, PS- Kotshila, Dist- Purulia and 02/03 others as per law and arranged for its investigation.
