Sir,

In producing here with one arrested accused person namely Dupa Sing Mura (28) S/O Buru @ Chutu Sing Mura of Vill-Bandhdih, PO-Gagi, PS-Bagmundi, Dist-Purulia and brought under seizure i) One bladder containing approx 12 (Twelve) Ltrs. ID Liquor and 01 (one) plastic Jarican containing approx 10 (Ten) Ltrs. ID liquor, total 22 (twenty two) ltrs. ID liquor and ii) 01 (one) Motor Cycle Hero Splender having Reg. No-JH22C/4765 from his possession. I do hereby lodged this written complain to the effect that on 04/02/2021 at about 19:45 hrs, during evening mobile duty I received a telephonic source information that one person is carrying I.D. liquor (Mahula) from Bagmundi area in one motor cycle and coming towards Nimdih village for selling ID liquor at Nimdih village under Pusti GP. I informed the matter to I/C Jhalda P.S over phone and as per his direction myself along with force C/611-Jitandranath Pathak, C/696-Gorapada Pal, C/2929-Tarapada Mandal and NVF/843-Bibekananda Mahato vide C.C. No-327/2021 date 04/02/2021 left to work out the said source information. We reached at Nigdih village on Nimdih Torang road at about 20:25 hrs. and started NAKA checking and at 20:45 hrs. we found one person coming from Torang side towards Nimdih in one Motor cycle . We stopped him and searched. During search we found i) One bladder containing approx 12 ( Twelve) Ltrs. iD Liquor and 01 (one) plastic Jarican containing approx 10 (Ten) Ltrs. ID liquor, total 22 (twenty two) ltrs. ID liquor in his Motor cycle. I asked him to produce licence or any valid document in respect of ID liquor. But he failed to produce any valid document in respect of said ID liquor. During interrogation he disclosed his identity as noted above and confessed that he made those ID liquor at his Village and will sell at Nimdih village to the villagers in lieu of money. Accordingly I seized i) One bladder containing approx 12 ( Twelve) Ltrs. ID Liquor and 01 (one) plastic Jarican containing approx 10 (Ten) Ltrs. ID liquor, total 22 (twenty two) ltrs. ID liquor and ii) 01 (one) Motor Cycle Hero Splender having Reg. No-JH22C/4765 under proper seizure list duly signed by the witnesses as well as accd. person with proper label. I search for local witnesses but none is there. Larrested him maintaining all formalities of arrest.

On return to PS along with accd. person and all seizure articles. Put the accd. person in the Lockup after maintaining all formalities and seized articles kept in PS Malkhana and I pray a specific case may kindly be lodged against Dupa Sing Mura (28) S/O Buru @ Chutu Sing Mura of Vill-Bandhdih, PO-Gagi, PS-Bagmundi, Dist-Purulia and arrange for investigation.
